The driver of vehicle 1 is found to be at fault for the collision.

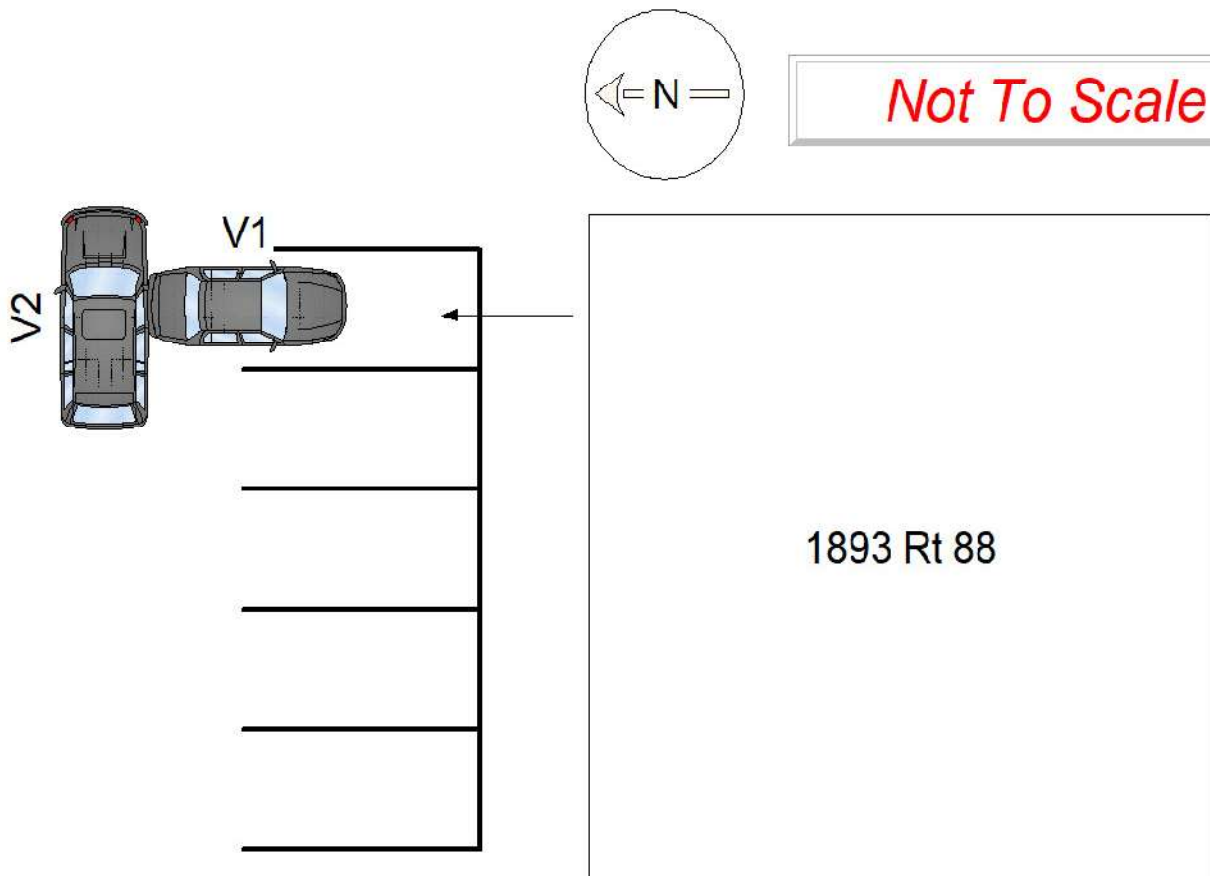
