145. Crash Description/Narrative

The driver of vehicle #2 stated she was in the right lane of Post Rd., attempting to turn left on to Rt. 88 westbound. She stated her traffic light turned green and she proceeded forward. As she moved through the intersection, she advised that vehicle #1 came out of nowhere and struck the front of her vehicle.

The driver of vehicle #1 stated he was traveling westbound on Rt. 88, in the left lane, approaching the intersection with Post Rd.. He stated that he had a green light and proceeded straight through the intersection. He further advised that vehicle #2 turned left in front of him causing the crash.

The driver of vehicle #3 stated she was east bound on Rt. 88, in the left lane, just west of the intersection with Post Rd.. She advised that she was stopping in traffic due to a red traffic light when vehicle #1 spun out of control and struck the middle driver side of her vehicle.

The driver of vehicle #2 complained of back pain and was transported to the satellite emergency room of Ocean Medical Center located in Point Pleasant.

Minor damage to vehicle #3. Moderate damage to both vehicle's #1 and #2.

Based on all of the drivers statements, a statement from a witness, as well as observing all the damage to the vehicles, it is my determination that vehicle #1 caused the crash by failing to observe a red traffic light at the intersection of Rt. 88 and Post Rd..

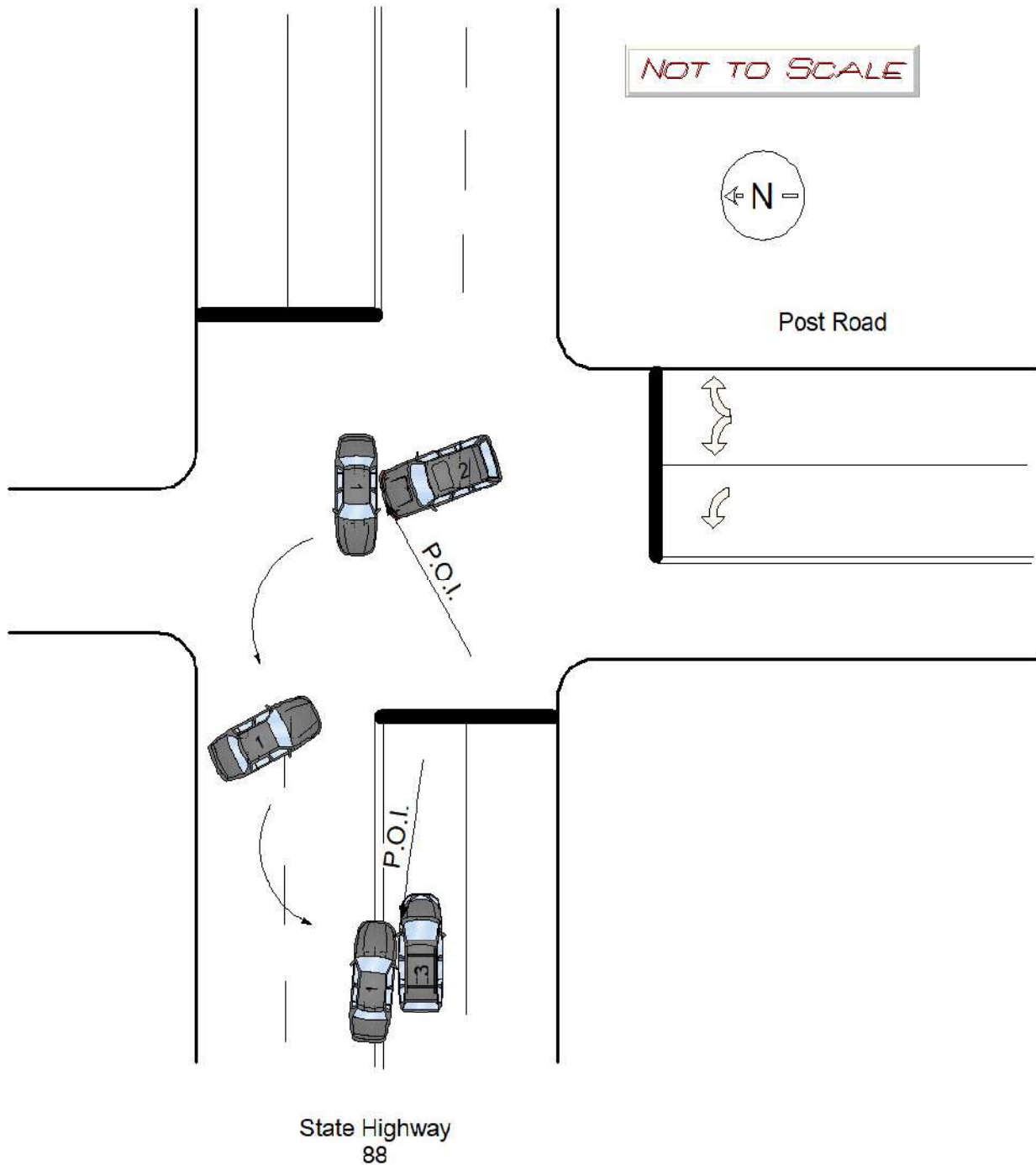
