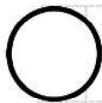

145. Crash Description/Narrative

Vehicle 1 and Vehicle 2 were stopped in traffic going south on Jack Martin Blvd. at the traffic signal at the intersection of Rt. 88. Vehicle 1 began to move forward and struck Vehicle 1 in the rear bumper with its front bumper. Vehicle 1 received no damage to the front bumper. Vehicle 2 had minor damage to the rear bumper.

Driver 1 advised he observed the traffic light turn green so he started to move forward before Vehicle 2 started moving causing the accident.

Driver 2 advised she was stopped in traffic when her vehicle was struck.

From my investigation and statements from both drivers I find Driver 1 at fault for following too closely.

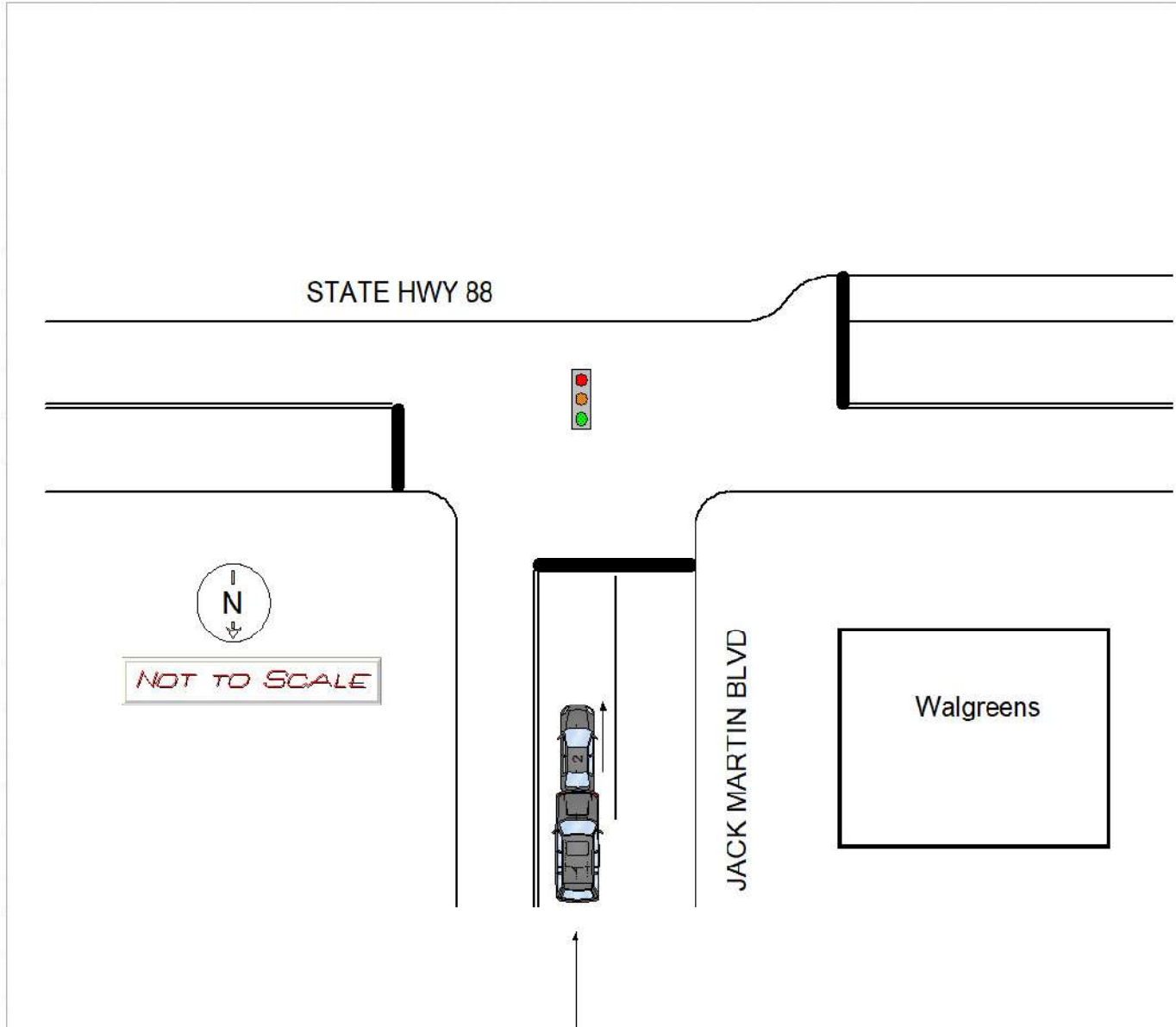
