145. Crash Description/Narrative

V1 was traveling eastbound in the right lane on Rt. 70 approaching the intersection of Olden St. V2 was traveling on the ramp from Rt. 70 eastbound onto Olden St.

V1 continued through the intersection of Rt. 70 and Olden St. despite the red traffic signal. V2 continued through the intersection of Rt. 70 and Olden St. at the green traffic signal.

V1 and V2 collided in the intersection resulting in front airbag deployment on both vehicles.

D2 had a complaint of head pain and was assessed by Brick Township Police EMS and released with an RMA.

A witness in the vehicle directly behind V2 advised the traffic signal was green for V2.

D1 was issued E20-4320 for Disregard of Traffic Signal 39:4-81.

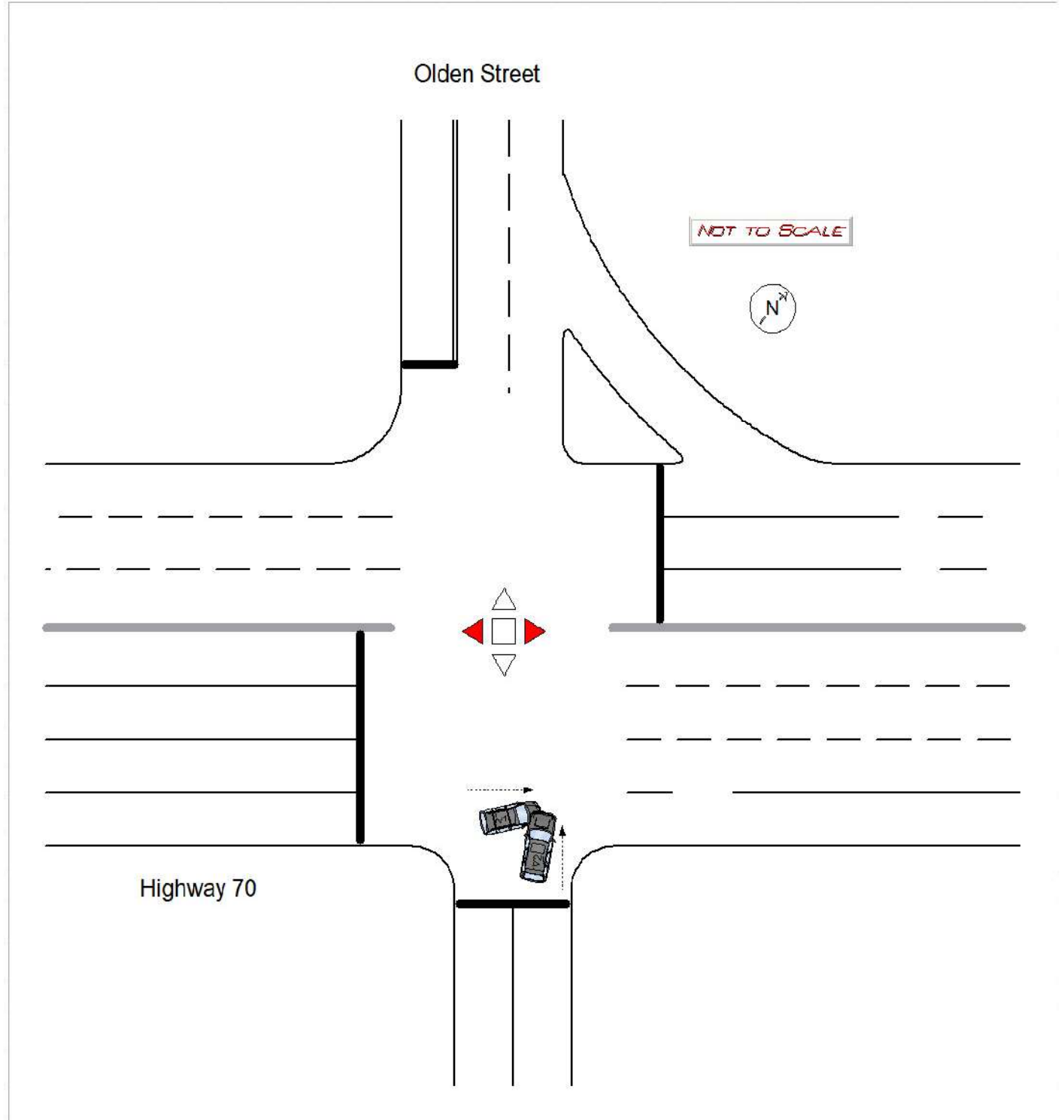
