145. Crash Description/Narrative

Vehicle #1 struck Vehicle #2 while backing out of a parking stall located at 1451 Route 88 (Laurelton Gardens).

Moderate damage sustained to both vehicles. Rear bumper of Vehicle #1 impacted Vehicle #2 passenger side doors.

Vehicle #1 operator stated while she was backing, she did not observe Vehicle #2 in her rearview mirror when the collision occurred.

Vehicle #2 operator stated she was traveling through the parking lot and did not see Vehicle #2 backing out of a spot, which struck the middle passenger side of her vehicle.

No injuries were reported.

Vehicle #1 operator was issued BTPD summons #E20-3655, under N.J.S.A. 39:4-97 (Careless Driving).

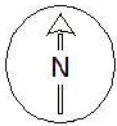

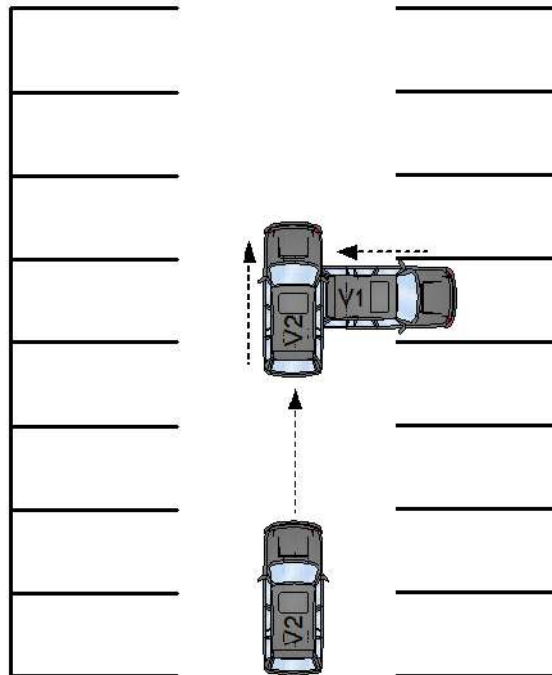

144 Crash Diagram (NOT TO SCALE)

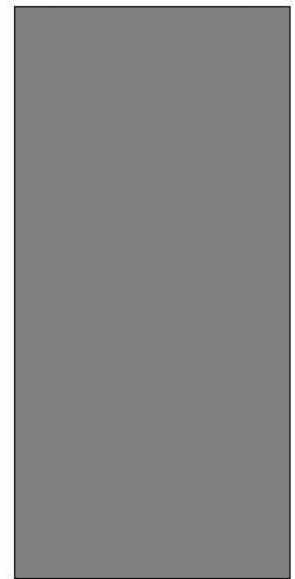
