145. Crash Description/Narrative

Vehicles 1 and 2 were both driving east on Route 88. Vehicle 1 was directly behind Vehicle 2. An unidentified vehicle which was directly in front of Vehicle 2 came to a sudden stop because it slightly passed Clay Avenue where it was trying to turn left. Vehicle 2 came to a sudden stop to avoid the stopped vehicle. Vehicle 1 attempted to stop behind Vehicle 2 but slid due to the wet road conditions causing Vehicle 1 to impact the rear of Vehicle 2.

Driver 1 advised he observed the vehicle in front of Vehicle 2 stop abruptly at which time Driver 1 started to brake. Driver 1 stated when Vehicle 2 came to a complete stop Vehicle 1 began to slide on the wet black top causing the impact with Vehicle 2.

Driver 2 advised he had no choice but to slam on his brakes when the vehicle in front of him stopped. Driver 2 advised he was able to look in his rearview mirror and observe Vehicle 1 not being able to stop.

No injuries were reported on scene. Both vehicles were driven from the scene.

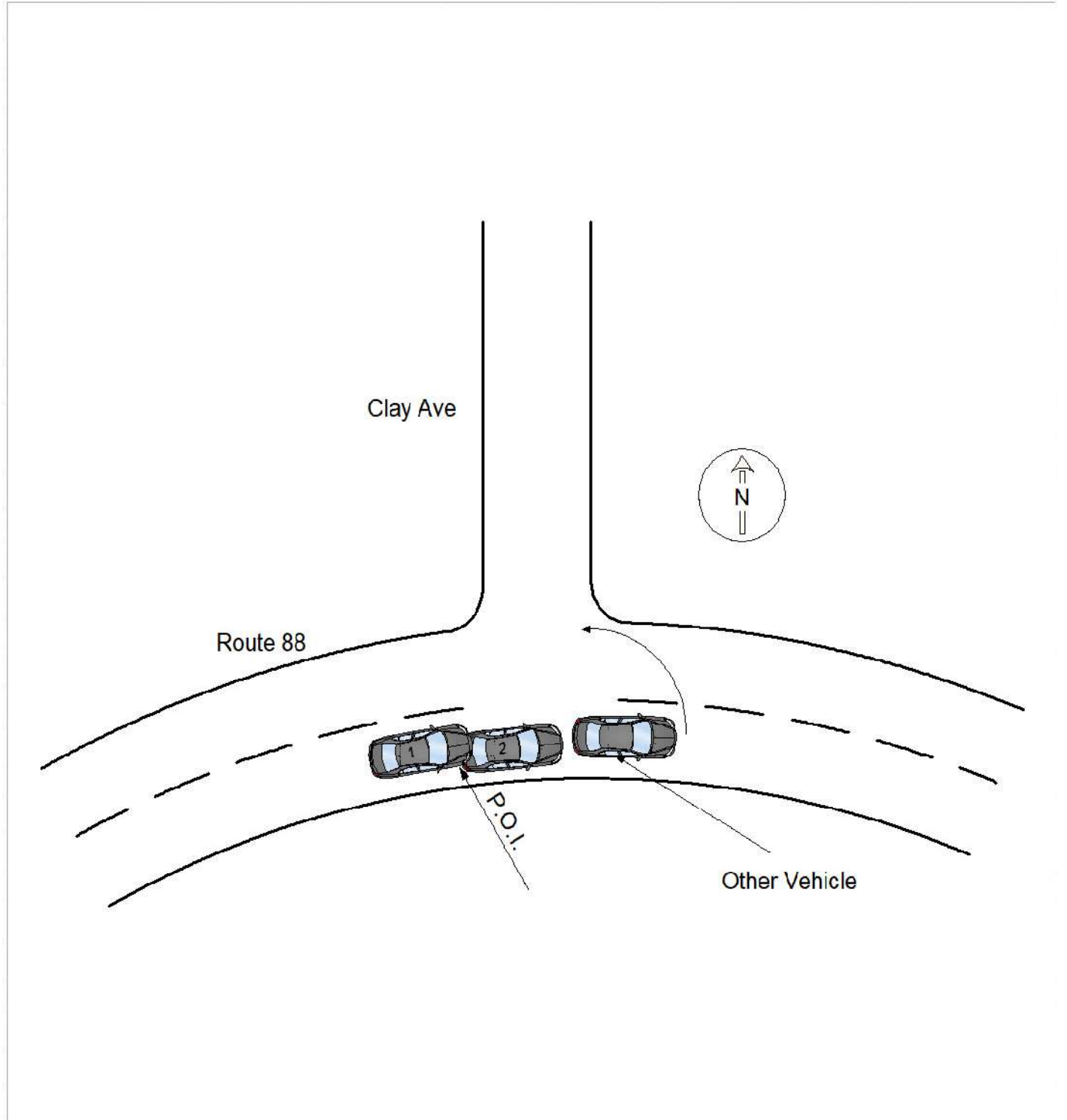
