145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 was in the left lane traveling West on Route 88 approaching the intersection with Post Rd. Vehicle 2 was directly in front of vehicle 1 in the same lane traveling West on Route 88. Vehicle 2 stopped in traffic as the light at the intersection turned red. Vehicle 1 was traveling too close to vehicle 2. When vehicle 2 stopped, driver 1 was unable to stop her vehicle in time which resulted in vehicle 1 crashing into the rear of vehicle 2.

Driver 1 stated she was traveling West on Route 88 and was directly behind vehicle 2. She observed vehicle 2 apply her turn signal and brake sharply approximately 20 feet prior to the intersection. Driver 1 attempted to apply her brakes but was unable to stop her vehicle in time.

Driver 2 stated she was traveling West in the left lane on Route 88 and stopped at a red light behind another vehicle at the intersection with Post Rd. While stopped she was struck in the rear without warning by vehicle 1.

Both refused medical attention at scene.

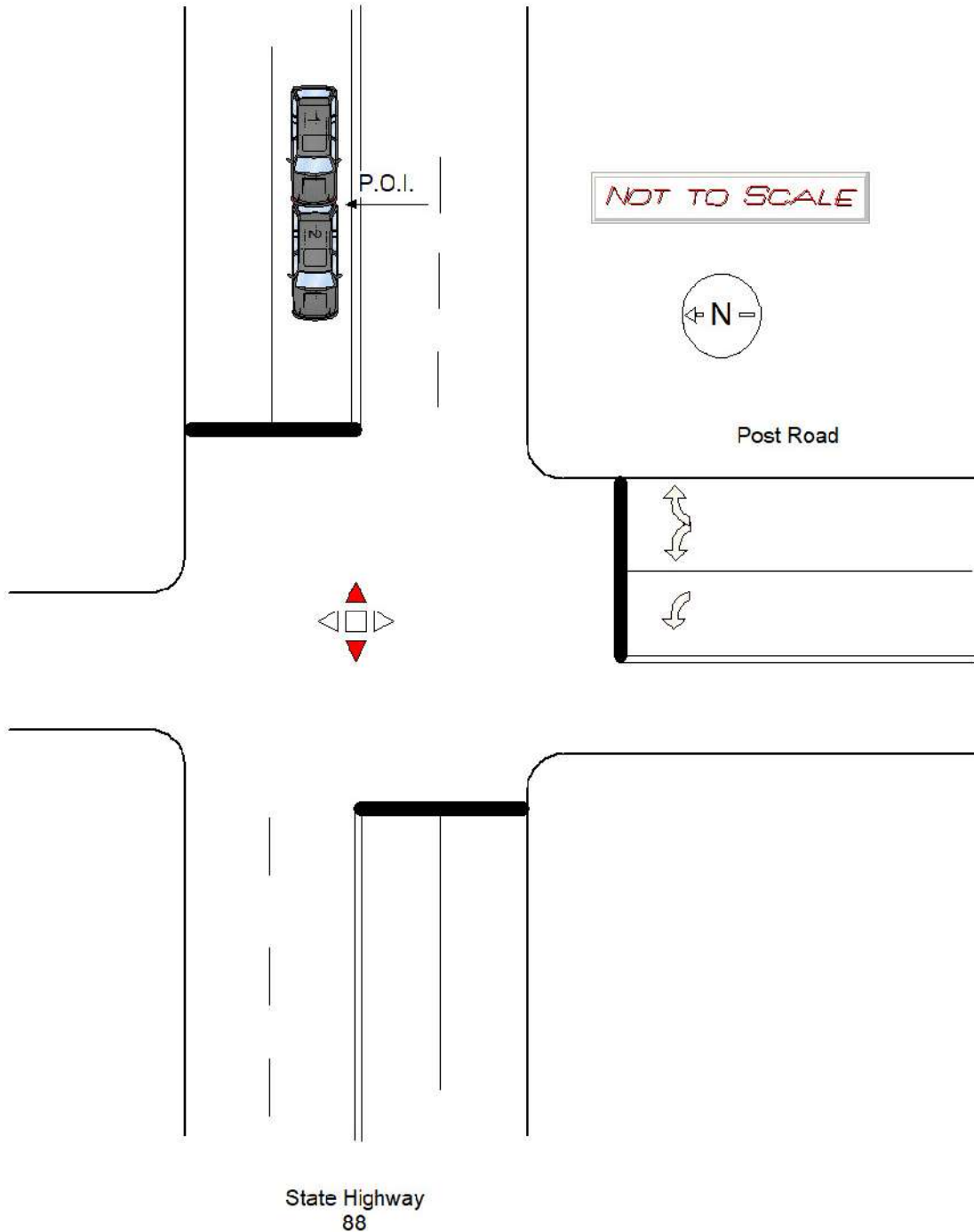
