145. Crash Description/Narrative

Vehicle 1 was traveling West on Route 88. While traveling West vehicle 1 ran off the right side of the roadway

striking a telephone pole (BT243BK) with the right front of the vehicle, which caused the telephone pole to break

in half. Vehicle 1 had all airbags deploy.

After striking the telephone pole vehicle 1 spun around in the roadway and came to rest on the westbound side of

the roadway. Both the driver and passenger exited the vehicle and were standing in a nearby parking lot upon

police arrival.

Both the parties involved in the accident claimed they weren't driving the vehicle. After questioning both

parties and finding a males shoe on the drivers floor. it was determined the male was the driver.

Standardized Field Sobriety Testing was administered to the driver of vehicle 1. Subsequently he was placed under

arrest. See Ptl. Hentges #288 case report.
