145. Crash Description/Narrative

Vehicle 2 was on Jack Martin Boulevard (CR-64), stopped at the red traffic signal, for the intersection of Rt. 88. Vehicle 1 was stopped directly behind Vehicle 2. The traffic signal for Vehicle 2 was red, however, the intersection allows right on red after a complete stop and roadway is clear to enter. Vehicle 2 proceeded slowly forward to see if the roadway was clear to make the right turn from Jack Martin Boulevard onto Rt. 88. Vehicle 2 stopped due to an on coming vehicle on Rt. 88. Vehicle 1 observed Vehicle 2 moving and proceeded forward. Vehicle 1 struck Vehicle 2 with Vehicle 1's front portion causing moderate but function damage to Vehicle 2's rear portion.

Driver 2 stated she was stopped at the traffic signal on Jack Martin Boulevard prior to making a right onto Rt. 88. She stated Vehicle 1 was directly behind her stopped as well. Driver 2 stated she started moving forward to see if the roadway was clear for her to turn onto Rt. 88. She observed a vehicle coming and stopped. After she stopped Vehicle 1 struck the rear of her vehicle.

Driver 1 stated he was on Jack Martin Boulevard behind Vehicle 2 at the red traffic signal. He observed Vehicle 2 proceed forward. Driver 1 stated he believed Vehicle 2 was making the turn so he looked left in order

to see if the roadway was clear for him to enter. While he was looking left he began traveling forward. Driver 1 stated he struck the rear of Vehicle 2 with the front of his.

No injuries were reported on scene. Both Vehicle 1 and Vehicle 2 were driven from the scene by their drivers.

Upon completion of my investigation, I have determined Vehicle 1 to be at fault for the motor vehicle crash. Vehicle 1 failed to observe Vehicle 2 in front of his vehicle stop prior to making the right turn onto Rt. 88. Based on my findings I issued Driver 1 a motor vehicle summons, E20 2354 for careless driving, 39:4-97.
