145. Crash Description/Narrative

A motor vehicle crash occurred on Route 70 westbound approximately 100 feet east of the intersection to Route 88, commonly referred to as the interchange.

Driver of Vehicle #1 advised she was stopped at the red traffic signal on Route 70 westbound in the middle lane of travel. Driver #1 advised she observed the traffic signal turn green. She began to move forward and the vehicle in front of her did not. Driver #1 advised she struck the rear of Vehicle #2.

There was minor damage to the front of Vehicle #1.

Driver of Vehicle #2 advised he stopped at the red traffic signal on Route 70 westbound in the middle lane of traffic. Driver #2 advised he was struck from behind by Vehicle #1.

There was moderate damage to the rear of Vehicle #2.

There were no reported injuries while on scene.

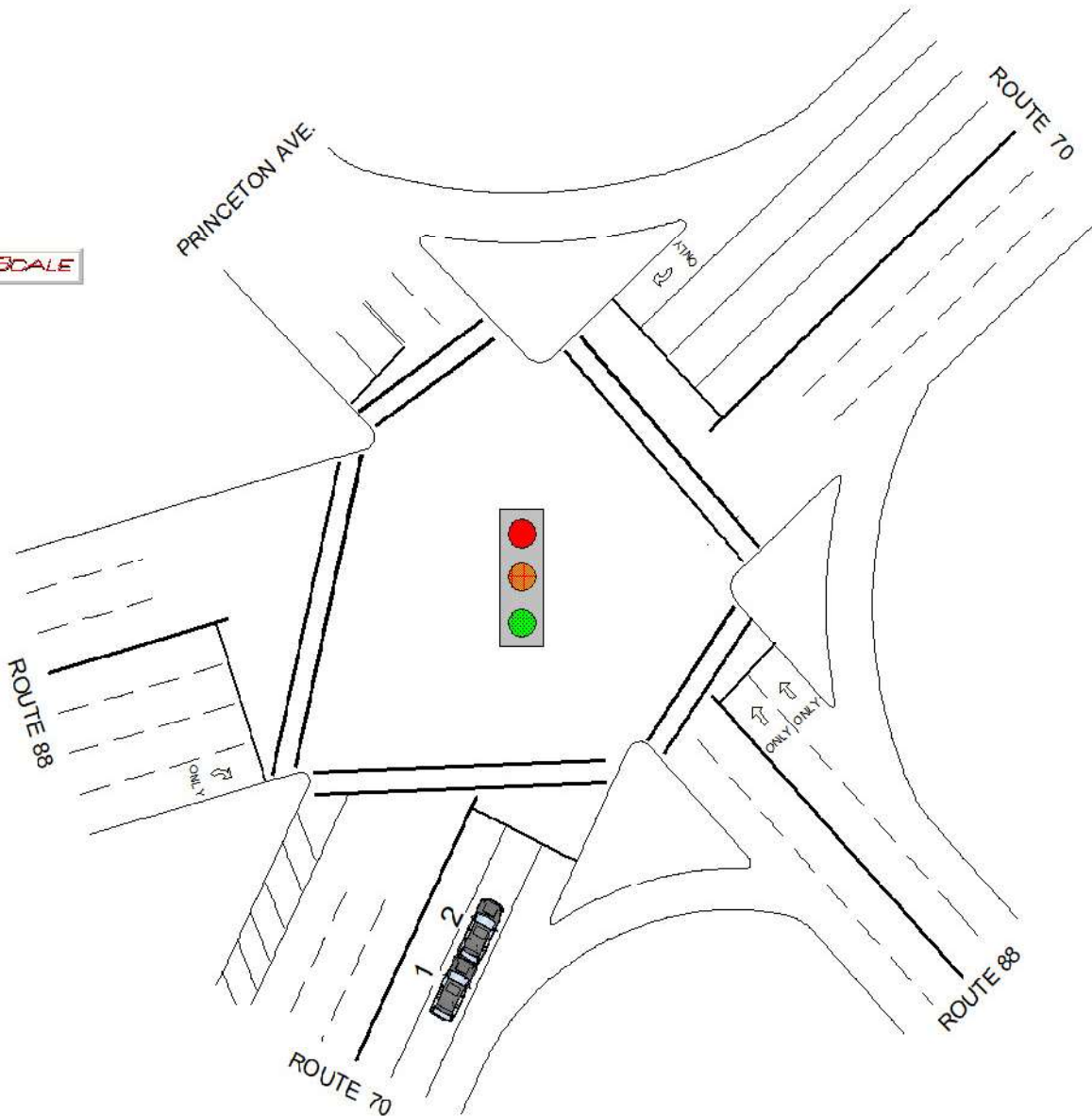
