145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 1 traveled eastbound on Route 70 in the middle lane approaching Route 88. Vehicle 2 traveled eastbound on Route 70 in the right lane approaching Route 88. As both vehicles approached Route 88, vehicle 1 hit vehicle 2 on the drivers side by the door. Both vehicles received minor damage.

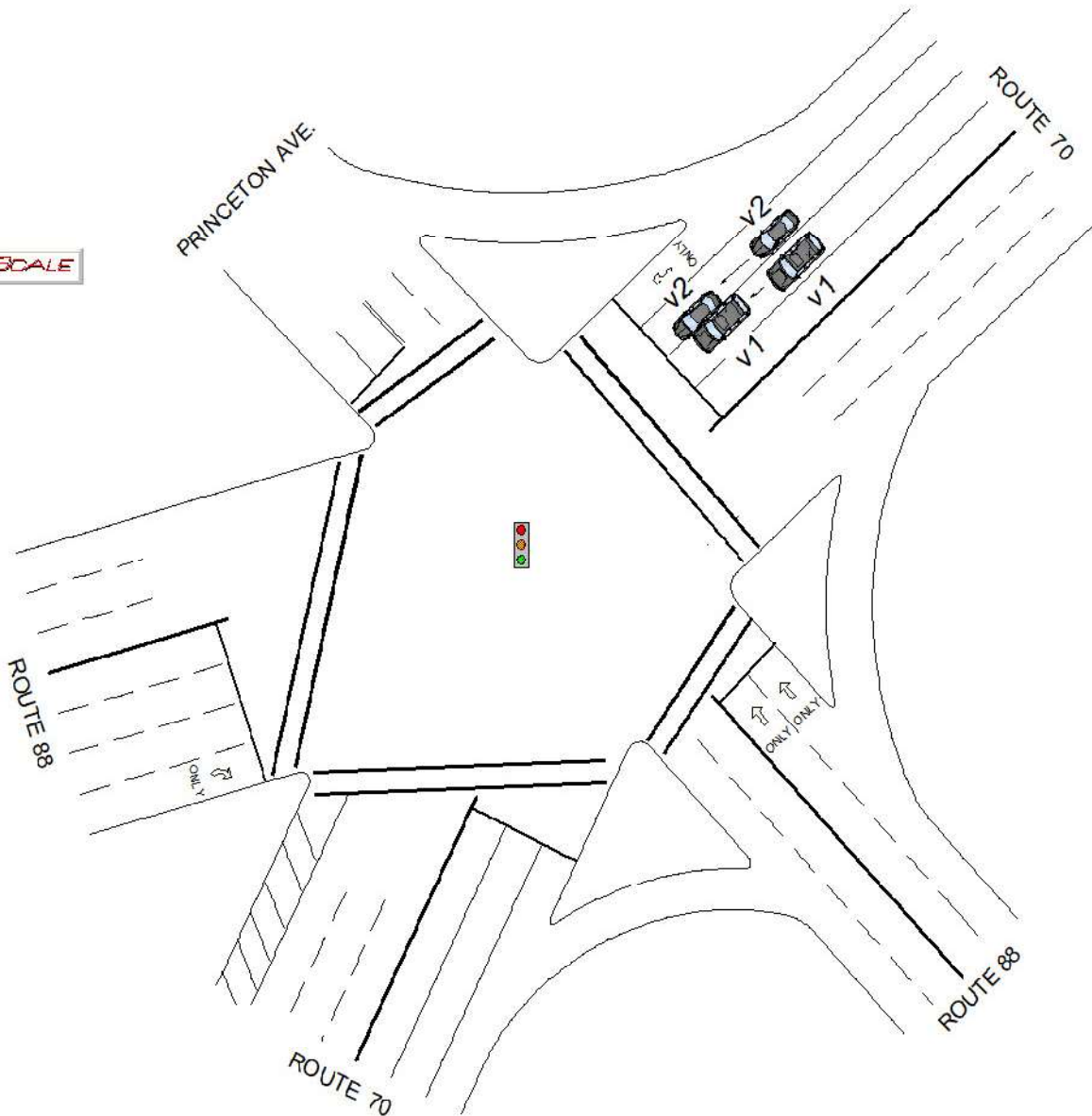
