145. Crash Description/Narrative

Vehicle #01 was traveling west on State Highway 88, approaching the intersection with Bruce Street. Vehicle #02 was traveling east on State Highway 88 and was approaching the intersection with Bruce Street. Vehicle #03 was traveling east, directly behind vehicle #02.

Vehicle #01 failed to maintain its travel lane as it drove past the Bruce Street intersection, crossed over the center lines and struck the left rear wheel area of a landscape trailer being towed by Vehicle #02, with the left front bumper area of vehicle #01. The impact significantly damaged and almost separating the rear axle from the trailer, disabling it. There was no damage observed on the towing vehicle #02.

After impact with the trailer, vehicle #01 continued into the eastbound lane and continued towards the side of the road, striking the left front bumper area of vehicle #03 with the right front bumper area of vehicle #01. Upon impact Vehicle #01 rotated to the right and caused significant disabling damage to both vehicle #01 and vehicle #03.

The driver of vehicle #02 was uninjured. Driver #01 initially denied any injuries and refused medical

attention, but later complained of pain to his back and knees. He and his mother (who arrived after the crash), both stated he would be taken to the hospital if necessary. Driver #03 was found lying in the roadway with a significant injury to her knee and possibly internal injuries. She was transported to Jersey Shore University Hospital for an evaluation and treatment. Vehicle #01 was towed to Surfside Collision while vehicle #03 was towed to Glen's Towing Service.

Driver #01 stated that he was driving west on Route 88 and crossed over the centerline where he first struck the trailer, then the other vehicle. When asked about what happened, driver #01 stated that he did not know. He denied falling asleep or using his cellular phone. He voluntarily showed me his cell phone call log and messaging log which did not show use at about the time (prior) of the crash. Driver #01 was checked for signs of impairment with negative results. There was nothing to indicate what happened to cause this crash observed inside vehicle #01.

Driver #02 stated that he was traveling east on Route 88 and observed vehicle #01 enter his lane slowly from the opposite direction. He thought the driver may have fallen asleep, though he did not look for or see the driver. Driver #02 stated he began to beep his horn while attempting to avoid the collision by driving to the right side of the road but was struck in the rear of the trailer he was pulling.

Driver #03 stated that she was traveling east on Route 88 directly behind a truck and trailer. She observed the truck swerve to the right and saw a gold colored car come straight at her. Driver #03 stated she attempted to avoid the crash by moving to the right but was unable to and was struck. After the impact she then crawled out of the vehicle and was assisted by a bystander and police.

On 08-03-20 I spoke to a witness, Casey Duffy who was traveling directly behind vehicle #03. Mrs. Duffy stated that she observed the truck and trailer move to the right and heard a vehicle horn beeping. She saw the tan car strike the trailer then vehicle #03. Mrs Duffy observed Driver #03 being assisted by another bystander and checked on Driver #01 who appeared uninjured but stated to her, "I'm going to jail." Mrs. Duffy did not know why he stated that to her but he did appear distraught.

The driver of Vehicle #01 failed to maintain his lane and while doing so struck two other vehicles traveling in the opposite direction, who attempted to avoid the collision by moving as far to the right as possible. It is unclear what distracted Driver #01, but something caused him to enter the oncoming lane without any corrective action. Driver #01 is at fault for this crash. Motor vehicle summons # 1506-T-159258 was issued for 39:4-97

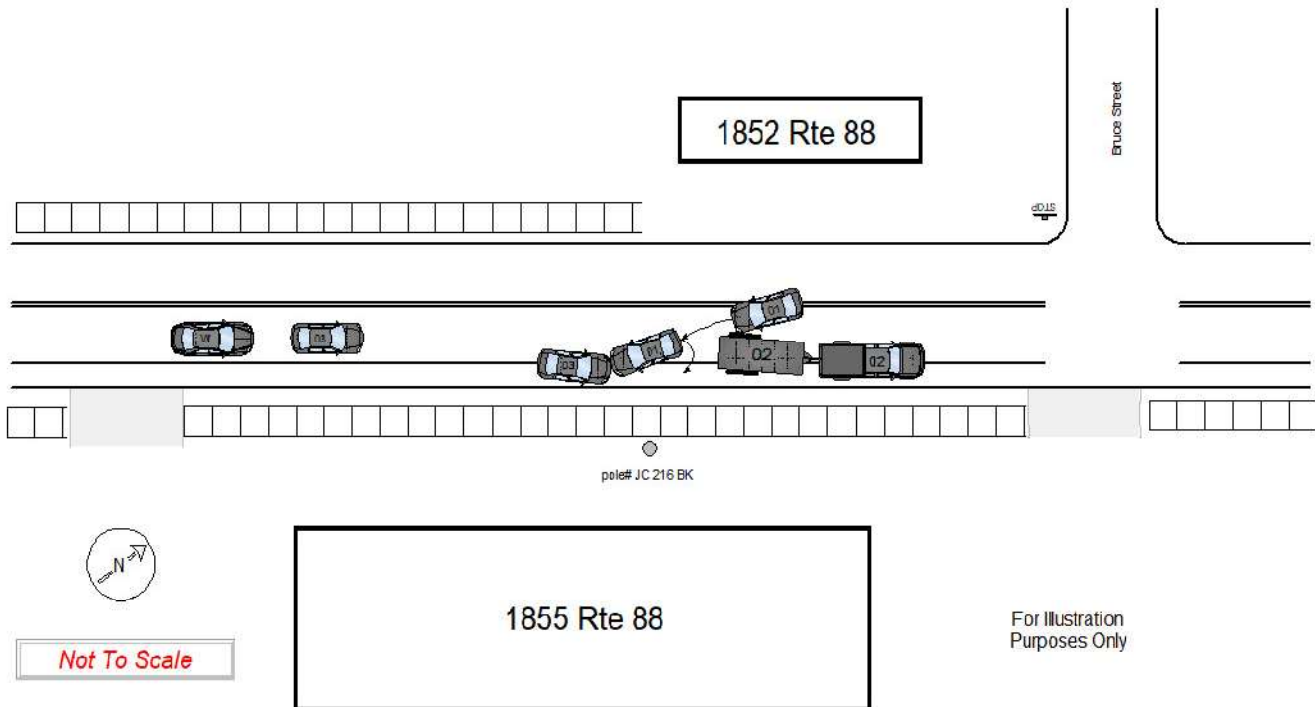
