145. Crash Description/Narrative

Vehicle 1 was traveling southbound on Jack Martin Blvd and made a right turn into the parking lot entrance of 1890 Rt. 88, Walgreens. Vehicle 2 was traveling southbound on the access road in the parking lot of 1890 Rt. 88, parallel to Vehicle 1. As Vehicle 1 turned into the parking lot entrance of 1890 Rt. 88 the front of Vehicle 1 collided with the left middle of Vehicle 2.

Driver 1 stated she was traveling southbound on Jack Martin Blvd going towards the intersection with Rt 88 in the right lane. She made a right turn into the parking lot entrance of 1890 Rt. 88, Walgreens. Driver 1 did not see Vehicle 2 and as she turned into the parking lot, subsequently causing the front of Vehicle 1 to collide with the left middle of Vehicle 2.

Driver 2 stated she was traveling southbound on the access road in the parking lot of 1890 Rt. 88, Walgreens. As she was passing the parking lot entrance, Vehicle 1 made a right turn into the parking lot entrance, causing the front of Vehicle 1 to collide with the left middle of Vehicle 2. Driver 2 showed me dash camera footage of the collision from her phone which showed while she was driving in the parking lot access road Vehicle 2, did not exceed 15 mph and the intersection with the parking lot entrance was clear at the time she entered it.

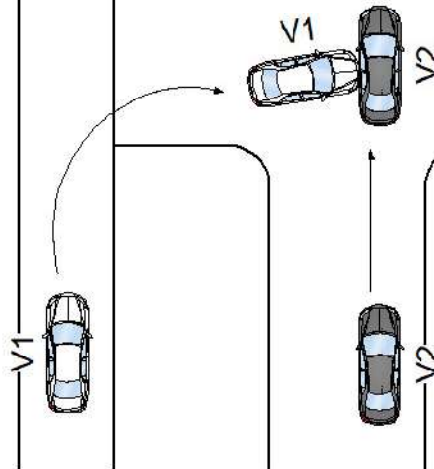
