145. Crash Description/Narrative

Vehicle 1 was traveling westbound on Rt. 88 heading towards the intersection of Olden Street. Vehicle 2 was stopped at the traffic light at the intersection of Olden Street and Rt. 88. Vehicle 1 entered the intersection at the same time Vehicle 2 entered the intersection, subsequently causing the front of Vehicle 1 to collide with the right middle of Vehicle 2.

Driver 1 stated he was driving westbound on Rt. 88 approaching the intersection with Olden Street. Driver 1 stated he saw the light was green and proceeded to go straight through. As Vehicle 1 entered the intersection Vehicle 2 darted across the intersection without stopping at the light, causing the front of Vehicle 1 to collide with the right middle of Vehicle 2.

Driver 2 stated he was heading northbound on Olden Street stopped at the traffic signal with Rt. 88. The traffic signal turned green and Driver 2 accelerated into the intersection as Vehicle 1 entered the intersection from Rt. 88 westbound, causing the front of Vehicle 1 to collide with the right middle of Vehicle 2.

Based on my observations and the statements made by both parties involved, I determined Driver 1 to be at fault

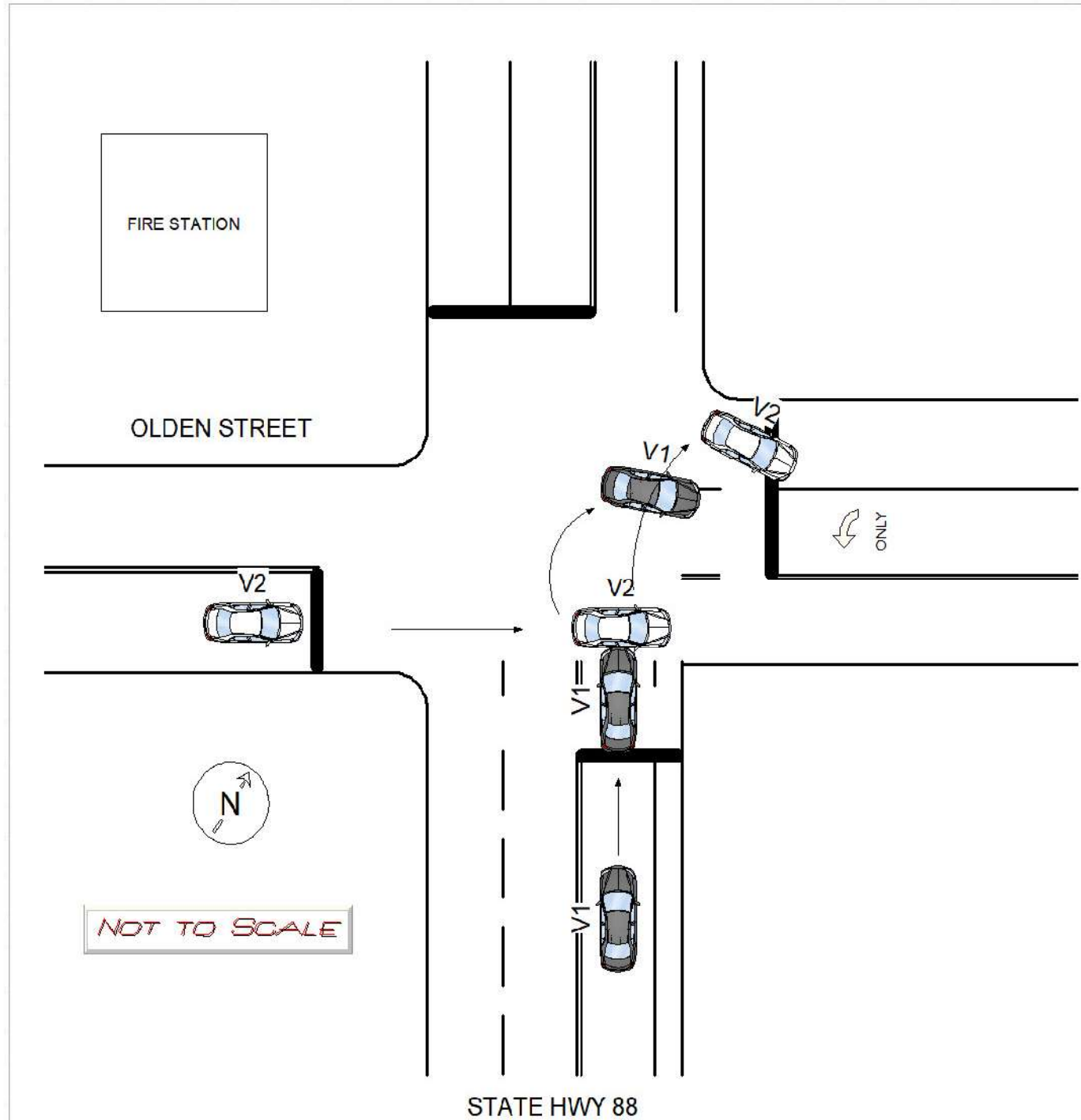
