145. Crash Description/Narrative

Vehicle #1 was traveling eastbound in the right most lane of Route 70, approaching Route 88. Vehicle #2 was directly behind Vehicle #1.

Driver #1 stated she was stopped in traffic when Vehicle #2 struck her from behind.

Driver #2 stated he was stopped behind Vehicle #1 when Vehicle #1 began to move forward. He thought traffic was going to be moving so he began to accelerate but Vehicle #1 did not continue moving forward. The front of his vehicle struck the rear of vehicle #1.

Based on my observations and statements made by both drivers, I determined Driver #2 to be at fault for the crash.

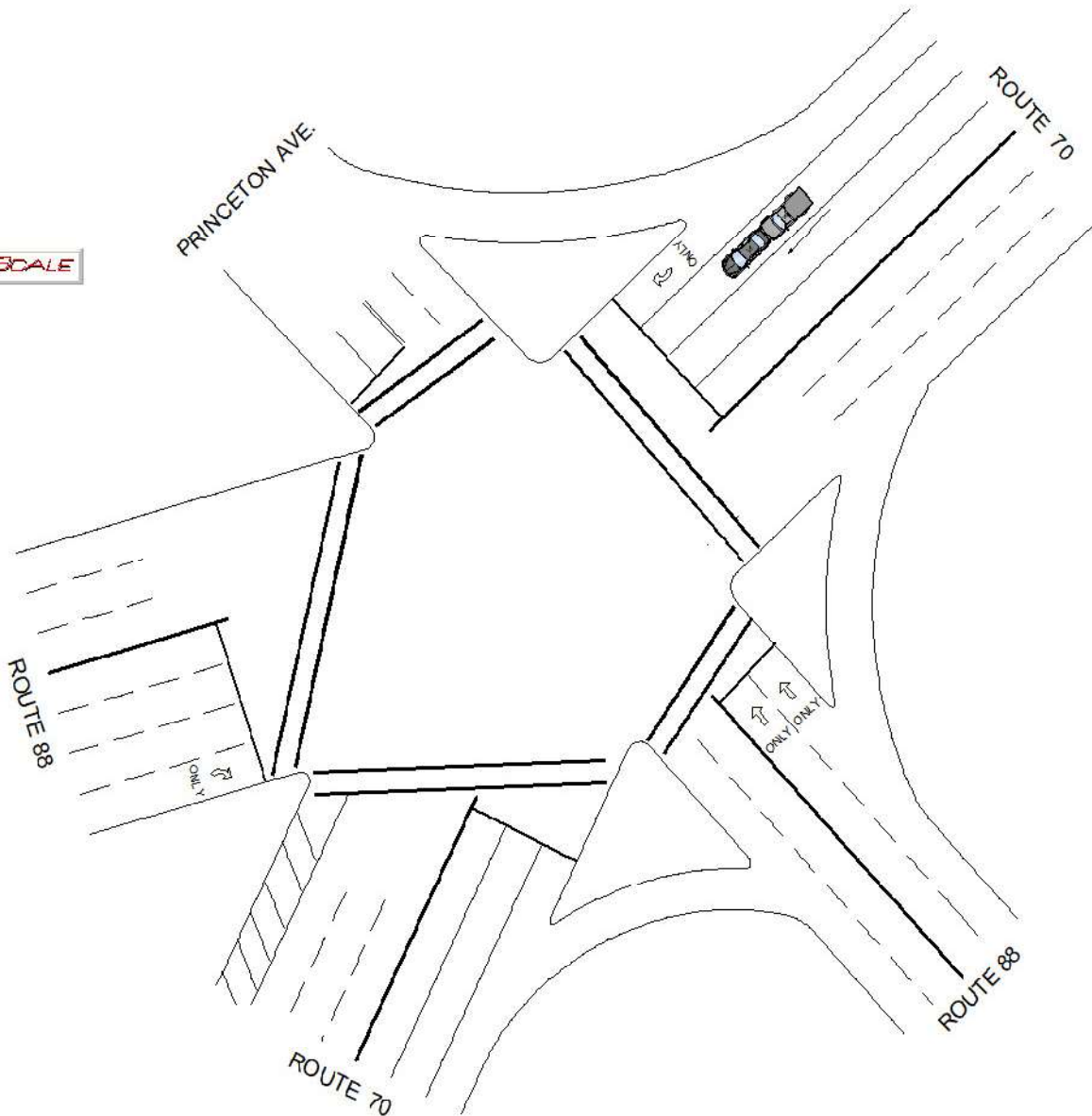
