145. Crash Description/Narrative

Vehicle #1 was traveling eastbound on RT 70 through the interchange on to RT 88 Eastbound. Vehicle #1 then traveled into the left lane then off the road and struck the curbed median. Vehicle #1 then collided with Vehicle #2 which was stopped in traffic in the left lane on RT 88 westbound side.

Driver of Vehicle #1 stated as he turned onto RT 88 eastbound in the right lane his front left tire blew out causing him to loose control of the vehicle. Driver #1 stated he attempted to utilize his brakes to regain control of the vehicle but the vehicle veered off the road to the left and over the curbed median. Driver #1 stated once the vehicle hit the curb his right tire also blew out before colliding with the front left of Vehicle #2 in the left lane of RT 88 westbound. Vehicle #1 sustained front end damage as well as two flat tires. It should be noted I observed tire marks approximately 50 feet from where the crash occurred indicating Driver #1 attempted to use brakes to avoid crash.

Driver #2 stated she was stopped in traffic in the left lane of RT 88 westbound near the interchange. Driver #2 stated while stopped she observed Vehicle #1 coming towards her vehicle but had no time to react. Vehicle #2 sustained front left end damage.

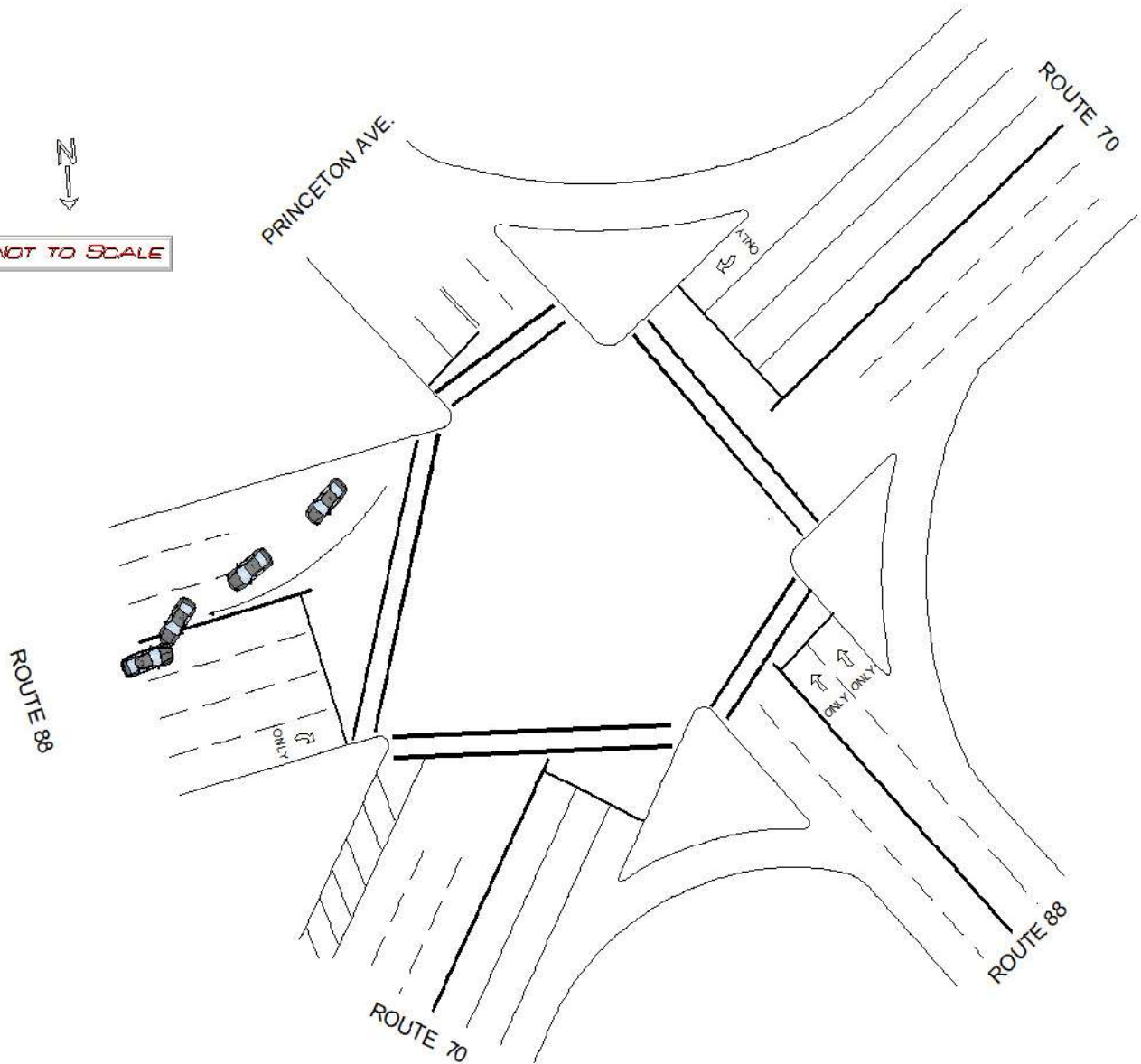
