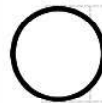

145. Crash Description/Narrative

A motor vehicle crash occurred on Route 70 approximately 200 feet east of the intersection to Olden Street.

Driver of Vehicle #1 advised he was stopped in traffic on Route 70 westbound. Driver #1 stated he placed his truck into gear when the light turned green and his vehicle began moving forward. Driver #1 advised the vehicle in front of him did not move and he struck the rear of Vehicle #2.

Driver of Vehicle #2 advised he was stopped in traffic on Route 70 westbound. Driver #2 advised while stopped he was struck from behind by Vehicle #1.

There were no reported injuries while on scene.

Vehicle #1 struck the rear of Vehicle #2. Driver #1 is the at fault driver for following too closely and driver inattention.
