145. Crash Description/Narrative

The driver of vehicle #2 stated he was in the middle lane of Rt. 88, traveling west, stopped in traffic near the intersection with Rt. 70. He advised that vehicle #1 was directly behind him and struck the rear of his vehicle while he was stopped.

The driver of vehicle #1 stated she was directly behind vehicle #2. She advised that her foot slipped off of the brake which caused her vehicle to move forward. As a result she stated that she struck the rear of vehicle #2 with her vehicle.

Based on both of the drivers statements as well as observing the damage to both vehicles, it is my determination that vehicle #1 caused the crash by driving carelessly and failing to observe vehicle #2 directly in front of her.

Moderate damage to vehicle #2. Minor damage to vehicle #1. The driver of vehicle #2 complained of neck and back pain and was transported to Ocean Medical Center. The driver of vehicle #1 was not injured.

The driver of vehicle #1 received a summons for careless driving. 39:4-97 (T159278).

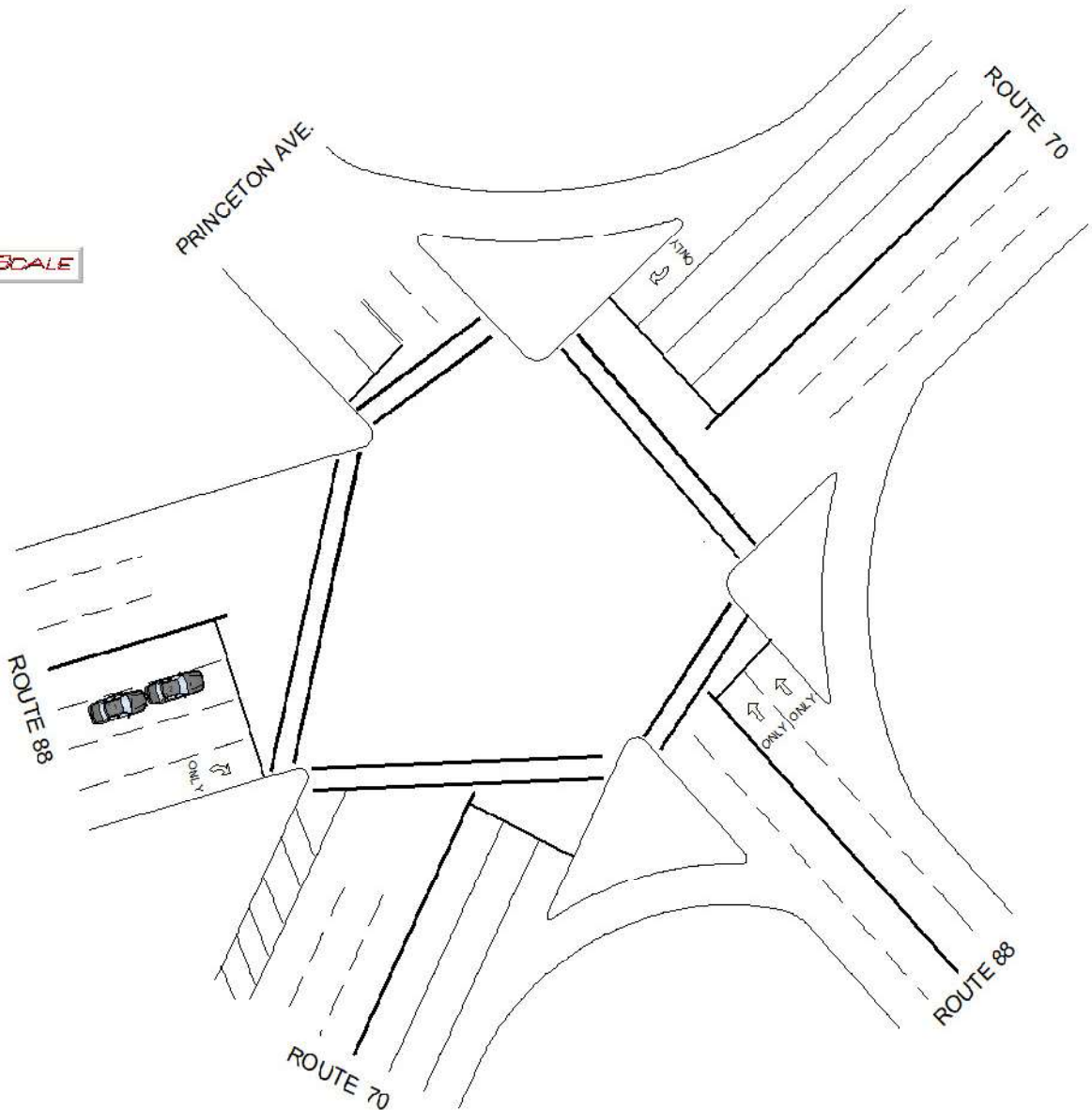
