145. Crash Description/Narrative

Vehicle 01 was traveling west on Jack Martin Blvd and in the right lane approximately 100' feet from Burrsville Rd struck Vehicle 02 in the rear.

Driver of Vehicle 01 stated she was traveling west on Jack Martin Blvd in the heavy rain and while attempting to stop in the right lane just prior to Burrsville Rd her vehicle slid into the rear of Vehicle 02.

Driver of Vehicle 02 stated he was stopped on Jack Martin Blvd north in the right lane behind several vehicles for the signal for Burrsville Rd when he was struck in the rear by Vehicle 01.

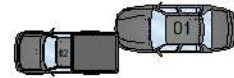
