145. Crash Description/Narrative

Vehicle #1 was traveling southbound on Burrsville Road approaching the intersection of Jack Martin Blvd. Vehicle #2 was attempting to make a left turn from Burrsville Road northbound onto Jack Martin Blvd.

Driver #1 stated he was approaching Jack Martin Blvd when there was a vehicle stopped in the left lane attempting to make a left turn onto Jack Martin Blvd. He merged into the right most lane and was attempting to continue straight through the intersection when Vehicle #2 made a left turn in front of him. He attempted to stop his vehicle to avoid the collision but was unable to before the front of his vehicle made contact with the passenger side rear tire of Vehicle #2.

Driver #2 stated she stopped in the intersection to make a left turn onto Jack Martin Blvd and began to proceed with her left turn. As she was already in the intersection making the turn, Vehicle #1 continued to go straight and did not stop or slow down when he saw her turning in front of him. Driver #2 states she did not see Vehicle #1 going in the right lane.

Based on my observations and statements made by both drivers on scene, I determined Vehicle #2 to be at fault for

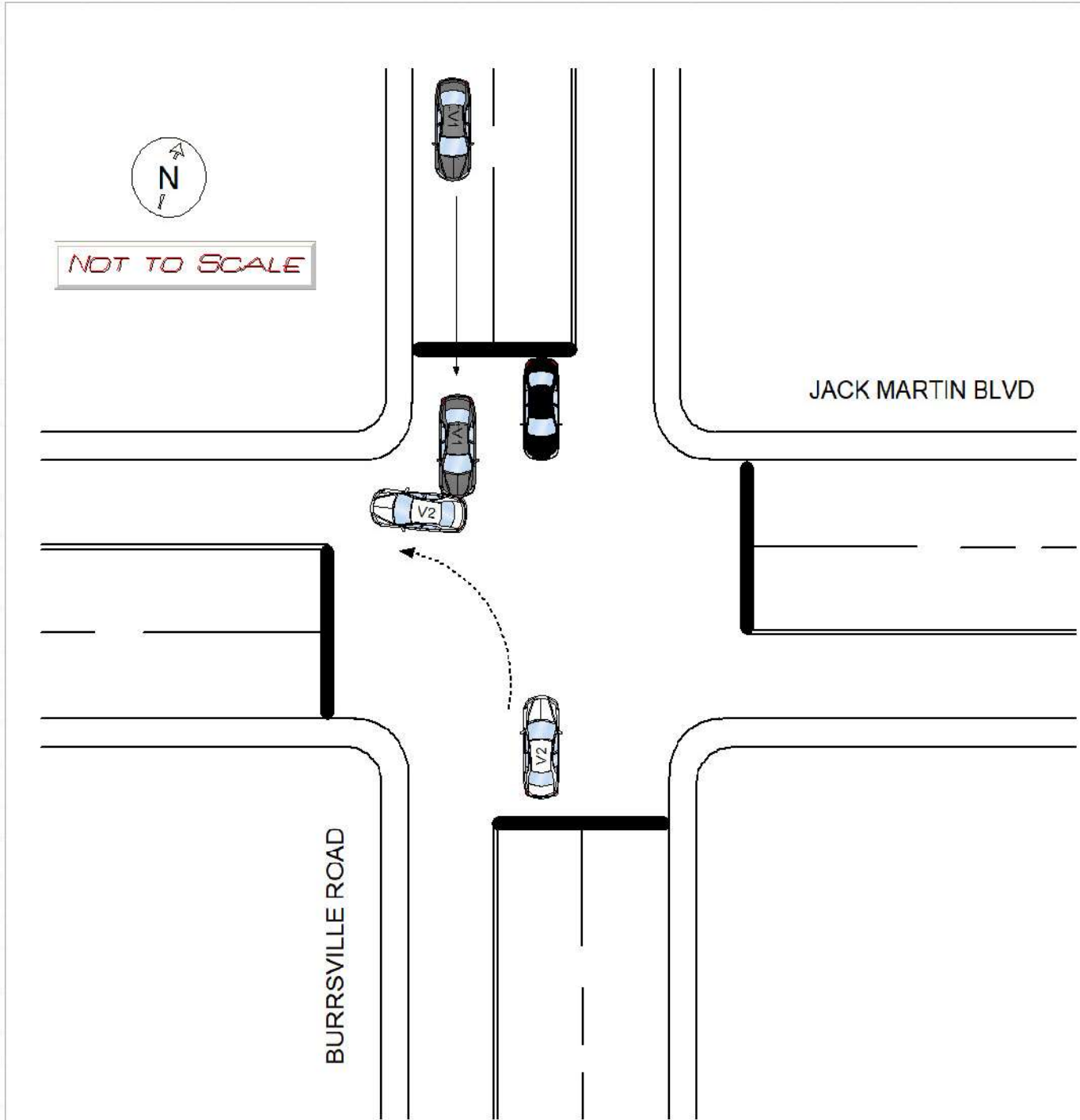
