145. Crash Description/Narrative

My investigation revealed the following: Vehicle 1 and vehicle 2 were both traveling south bound on Burrsville Road in the right travel lane. Vehicle 2 was waiting for the traffic signal to turn green to make a right onto Jack Martin Boulevard. Vehicle 1 was also waiting to make a right onto Jack Martin Boulevard from the right travel lane. Vehicle 1 struck the rear bumper of vehicle 2 with its front bumper. Both vehicles received minor damage.

Driver 1 stated he was waiting at the red traffic signal to make a right onto Jack Martin Boulevard. Driver 1 further stated he was looking down at his radio when he let his foot off the brake to move forward and struck vehicle 2.

Driver 2 stated she was waiting at the red traffic signal to make a right onto Jack Martin Boulevard when her vehicle was struck in the rear bumper.

I find the driver of Vehicle 1 at fault for failure to pay attention to traffic in front of his vehicle.

There were no injuries to report at this time and both vehicles were driven away from the scene.
