145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 1 traveled on Route 88 westbound in the right lane approaching Route 70. Vehicle 2 traveled on Route 88 westbound in the right lane approaching Route 70 in front of vehicle 1. Both vehicles were stopped in traffic at the red traffic signal. The traffic signal turned green when an unknown vehicle entered the right lane and caused vehicle 2 to stop. As vehicle 2 stopped for the unknown vehicle, vehicle 1 hit vehicle 2 and caused minor damage.

I spoke to driver 1 at the scene. She stated a vehicle cut them off and the car in front of her stopped and she hit the vehicle in front of her.

I spoke to driver 2 at the scene. He stated a vehicle cut him off and he stopped. As he stopped he was hit from behind.

Based on statements made vehicle 1 was determined to be the at fault vehicle.

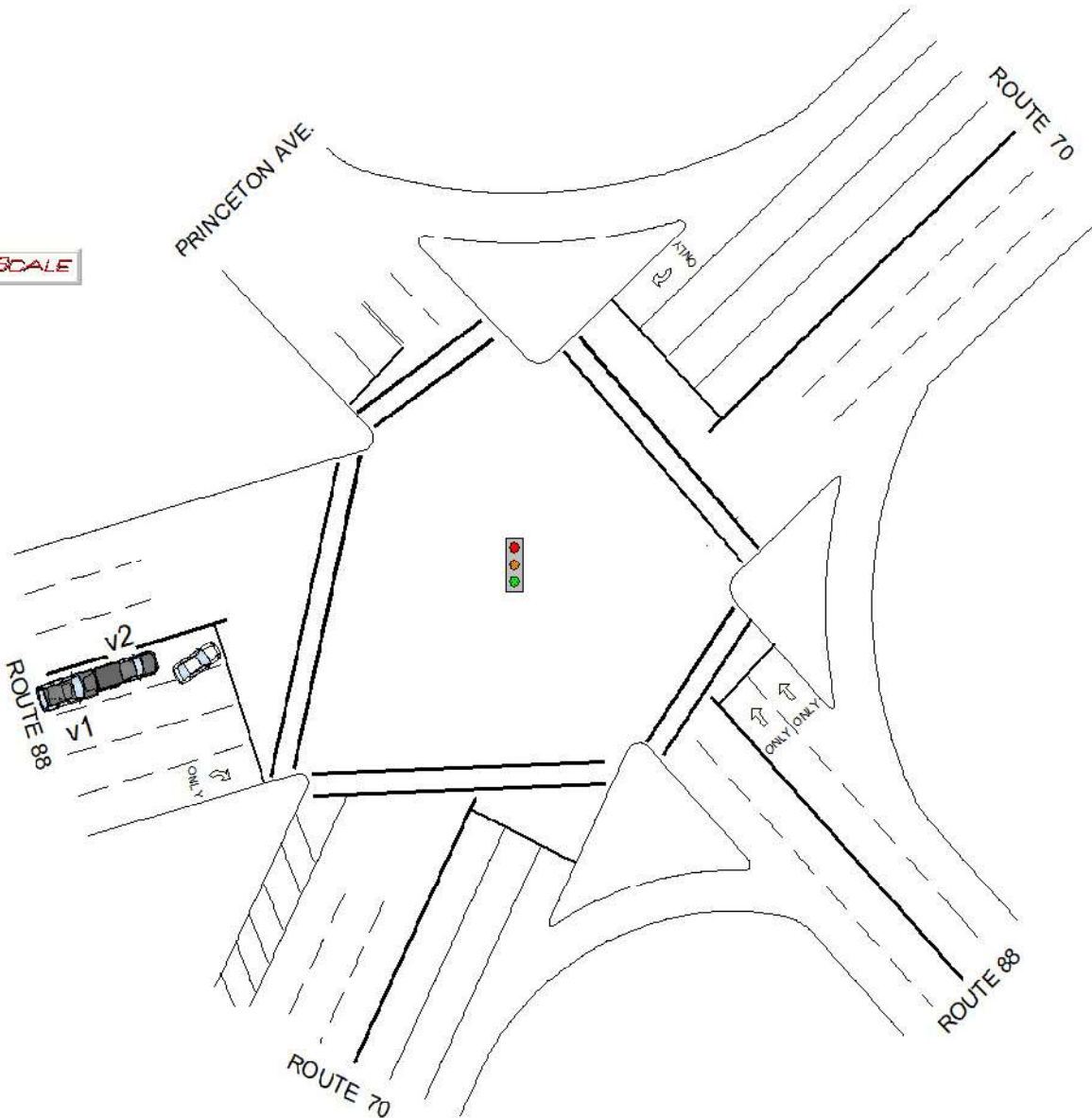
