145. Crash Description/Narrative

V1 was traveling southbound in the left lane on Burrsville Rd. approaching the intersection of Jack Martin Blvd.

V2 was traveling southbound in the right lane on Burrsville Rd., adjacent to V1.

V2 continued straight through the intersection. While V2 was in the intersection, V1 turned right from the left lane, in an attempt to travel west on Jack Martin Blvd. V1 struck V2.

D1 stated he had made a mistake in his directions and wished to turn right, despite being in the left lane. D1 stated he signaled his right turn from the left lane and began the turn. He stated he believed D2 sped up to pass straight through the intersection. He also stated he was unable to bring his vehicle to a complete stop before striking V2.

D2 stated she was traveling straight through the intersection from the right lane due to V1's left turn signal having been illuminated. As D2 entered the intersection, V1 struck V2.

Both vehicles were moved prior to my arrival.

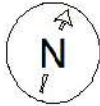

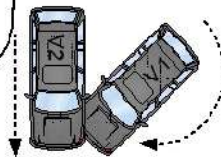
