145 Crash Description/Narrative

Driver #1 was operating a Toms River school bus south on Hooper in the middle lane, approaching Mapletree Road. Vehicle #2, an unknown type pick up truck towing a trailer was just ahead of Vehicle #1 in the left lane. Vehicle #2 then changed lanes into the middle lane when the rear of the attached trailer struck the driver's mirror of the school bus. Vehicle #2 continued to drive south down Hooper and Vehicle #1 turned down Mapletree and stopped to report the incident. The mirror sustained minor damage including cracked plastic. Both the driver and single student on the bus were uninjured. Vehicle #2 was unable to be located.

Motor Vehicle Crash Diagram

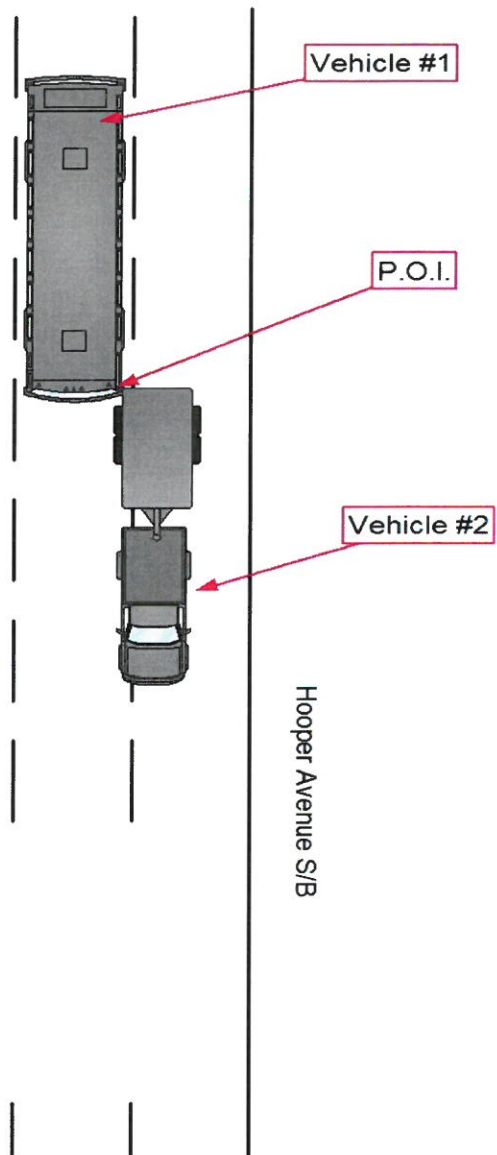
