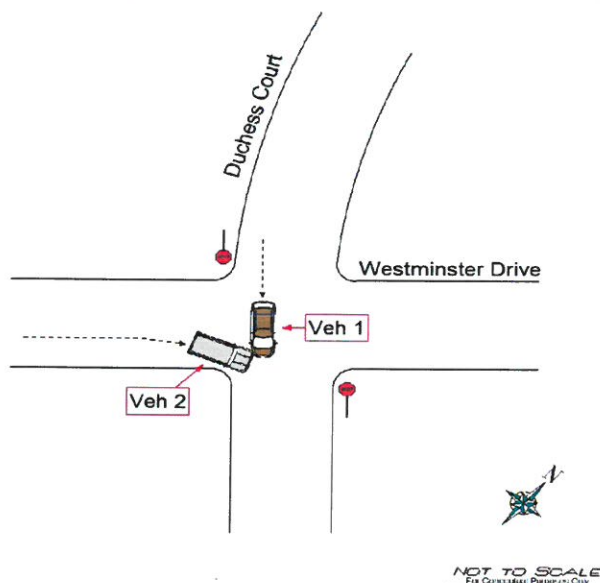

145 Crash Description/Narrative

Driver #1 reported that she was southeast on Duchess Court, proceeding forward from a stop sign at the intersection of Westminster Drive. She did not see vehicle #2 approaching on Westminster Drive because of the sun glare. She then collided with vehicle #2 with the passenger side front corner of her minivan. **Driver #2** reported that she was northeast on Westminster Drive, approaching the intersection of Duchess Court. As she reached this intersection vehicle #1 entered the intersection from Duchess Court from a stop sign. Driver #2 attempted to brake and steer to the right but collided with vehicle #1 with the driver's side front corner of her vehicle. Sun glare was observed at the scene while facing the southeast.
