145 Crash Description/Narrative

Driver #1 reported that she was westbound on Route 70 when she had to adjust her sun visor because of a strong sun glare facing west. She did not see that the traffic signal at the intersection of Massachusetts Avenue had changed to red and vehicle #2 had stopped ahead of her. Driver #1 attempted to brake but collided with vehicle #2 with the front of her car. Driver #2 reported that she was westbound in the center lane of Route 70, stopped at a red light at the intersection of Massachusetts Avenue. Her car was then struck from behind by vehicle #1. Sun glare was present at the scene facing west.

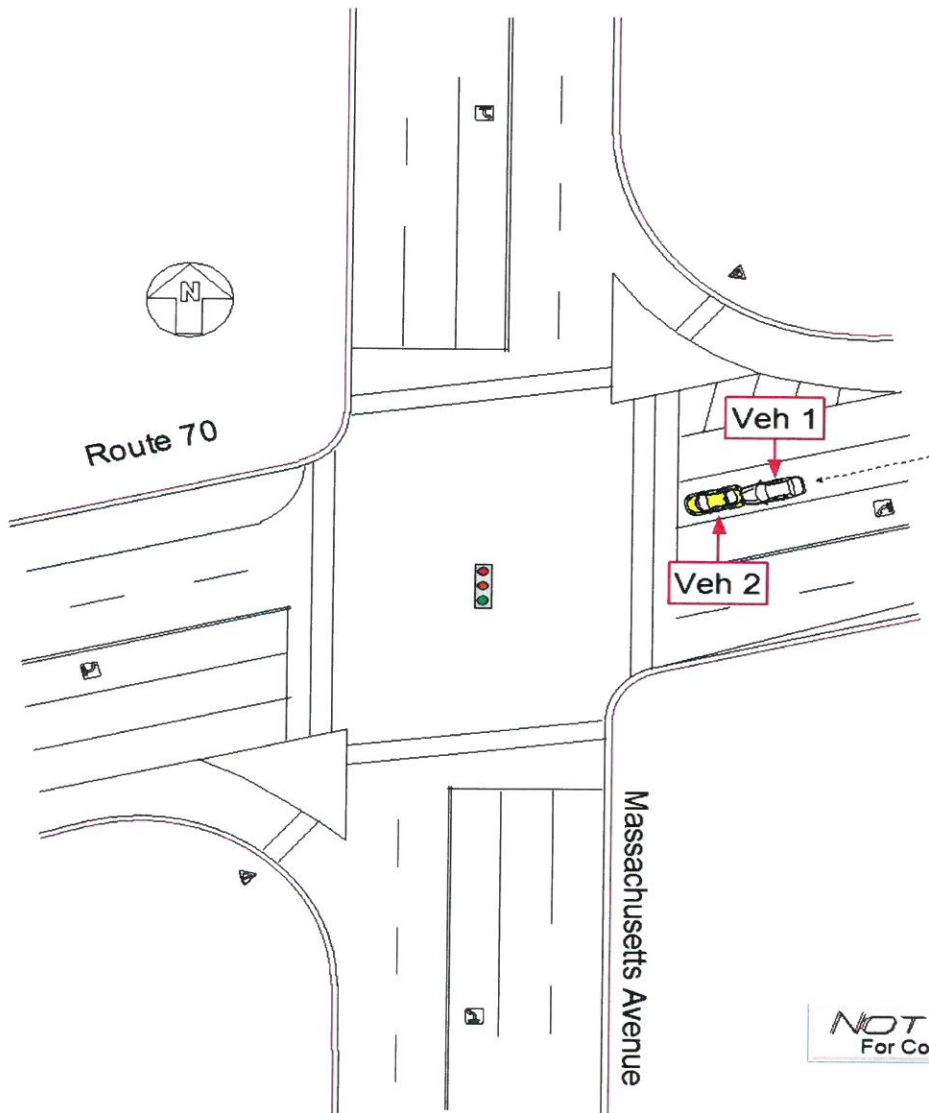
