145. Crash Description/Narrative

Two car crash occurred on 6/24/2020 at approximately 1631 hours eastbound on Route 70 near the intersection with Route 88. My body worn camera was on during this investigation.

Driver of vehicle #1 advised she looked away in order to locate the "battery store" near the intersection and did not see vehicle #2 stopped in front of her. She stated when she looked back she could not stop in time and struck the right lower rear of vehicle #2 with the left lower front of her vehicle.

Driver of vehicle #2 advised he was stopped for the red light behind approximately 3 other cars and was struck from behind by vehicle #1.

I observed a dent and paint transfer on the rear bumper of vehicle #2 and a broken headlight on the front of vehicle #1.

Driver of vehicle #1 is at fault for the crash for following too closely and driver inattention.

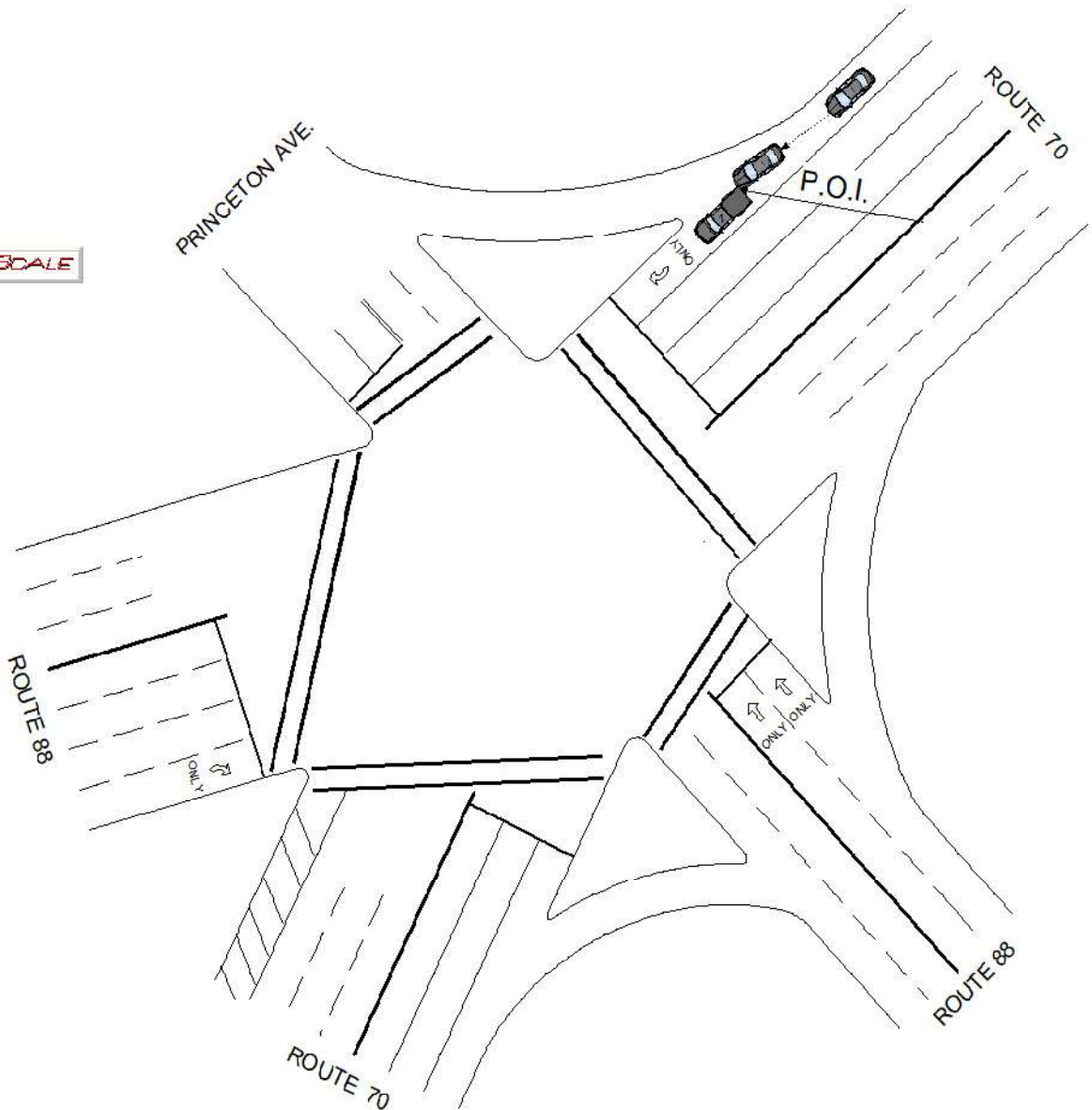
