145. Crash Description/Narrative

Investigation of accident concluded: Vehicle #1 and Vehicle #2 were traveling on Cedarbridge Ave. in the area of Jackson Ave. Vehicle #2 stopped with the flow of traffic when Vehicle #1 was following too closely, failed to stop and struck Vehicle #1 in the rear. Vehicle #1 is at fault.

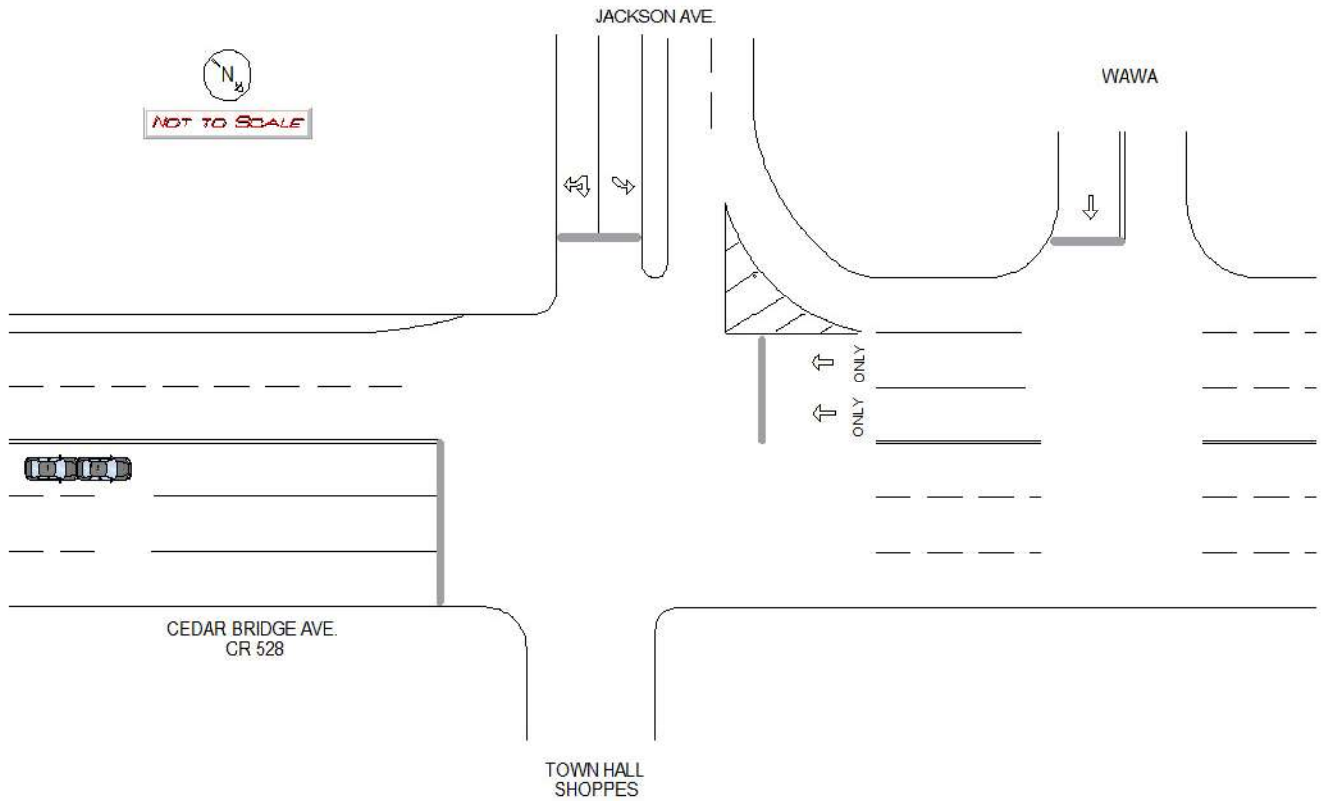
