145. Crash Description/Narrative

On scene I observed Vehicle #1 with disabling front driver side damage to his vehicle. Vehicle #2 had disabling front passenger side damage to her vehicle.

Driver #2 explained she was in the third lanes of Route 70 Eastbound about to merge onto the off ramp to enter Jack Martin Blvd when vehicle #1 failed to stop at the traffic signal. Once vehicle #1 failed to stop at the light he collided into vehicle #1.

Driver #1 explained he was stop at the traffic light, attempting to make a right turn onto Route 70 Eastbound, when vehicle #2 quickly went from lane #1 to lane #3 to get onto the ramp. He attempted to stop his vehicle prior to crashing into her but failed.

After my investigation, I found Driver #1 at fault for the crash and was issued a summons:

Motor Vehicle Crash Diagram

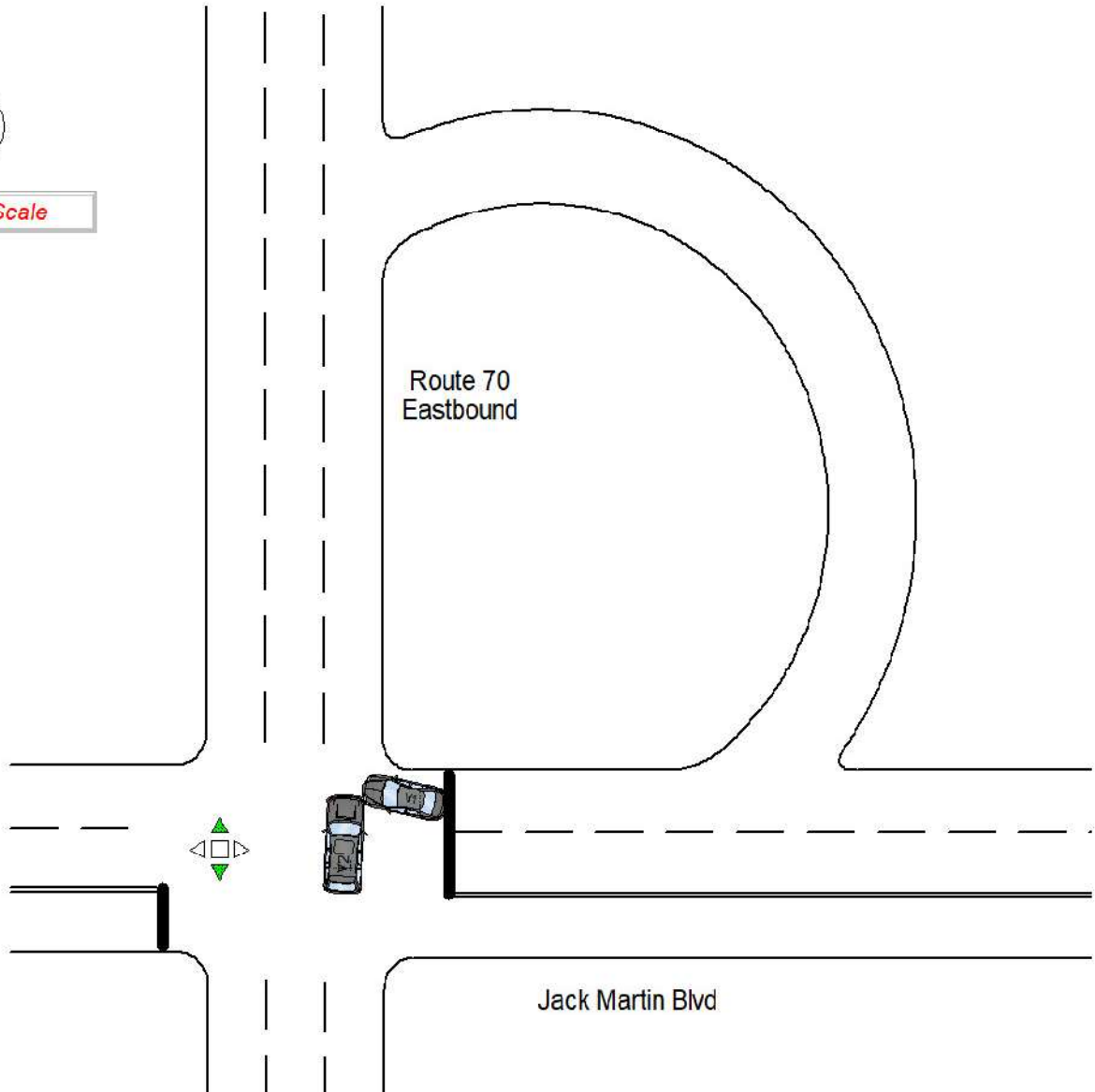
