145. Crash Description/Narrative

Vehicle #2 was parked, unoccupied, facing east on Beacon Ave., on the side of 525 Jackson Ave. Vehicle #2 was side swiped on the driver side doors. I observed extensive damage to both doors. When the vehicle was struck, it was pushed into brick pavers causing damage to the right passenger side rear tire. Vehicle #2 was struck by an unknown gray sedan vehicle who then fled the scene.

The registered owner of Vehicle #2 stated there was no previous damage to his vehicle prior to the crash and he was home since 1630 hours. He further stated around 1640 hours his daughters heard a loud crash. When he went outside to check, he observed a small gray sedan pass his vehicle heading east on Beacon Ave., but did not observe any damage to his vehicle due to it being on the left side. He stated he later came outside and observed the damage to the left side of his vehicle and contacted police to file a report. He was unable to provide the registration of the suspect vehicle or any further details.

A check of the area was negative for the suspect vehicle. Residents in the area have no exterior cameras in the area of the accident.

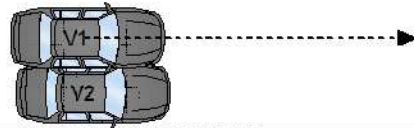
