145. Crash Description/Narrative

Vehicle #1 was traveling east on Route 70 in the center lane. Vehicle #2 was traveling the same direction in the left lane. Vehicle #1 changed lanes in the intersection of Jack Martin Blvd. where the front right bumper of Vehicle #2 struck the rear passenger side door of Vehicle #1. Both Vehicles were disabled in the roadway upon Police arrival.

Vehicle #1 operator stated he was traveling in the center lane of Route 70 EB. Vehicle #1 operator stated he attempted to change lanes into the left lane and did not see Vehicle #2 in his blind spot, causing the collision.

Vehicle #2 operator stated he was traveling in the left lane of Route 70 EB and Vehicle #1 was ahead of him in the center lane. Vehicle #2 operator stated Vehicle #1 cut in front of his vehicle in the intersection of Jack Martin Blvd. Vehicle #2 operator stated he believed Vehicle #1 was attempting to make a left turn from the center lane of Route 70 onto Jack Martin Blvd.

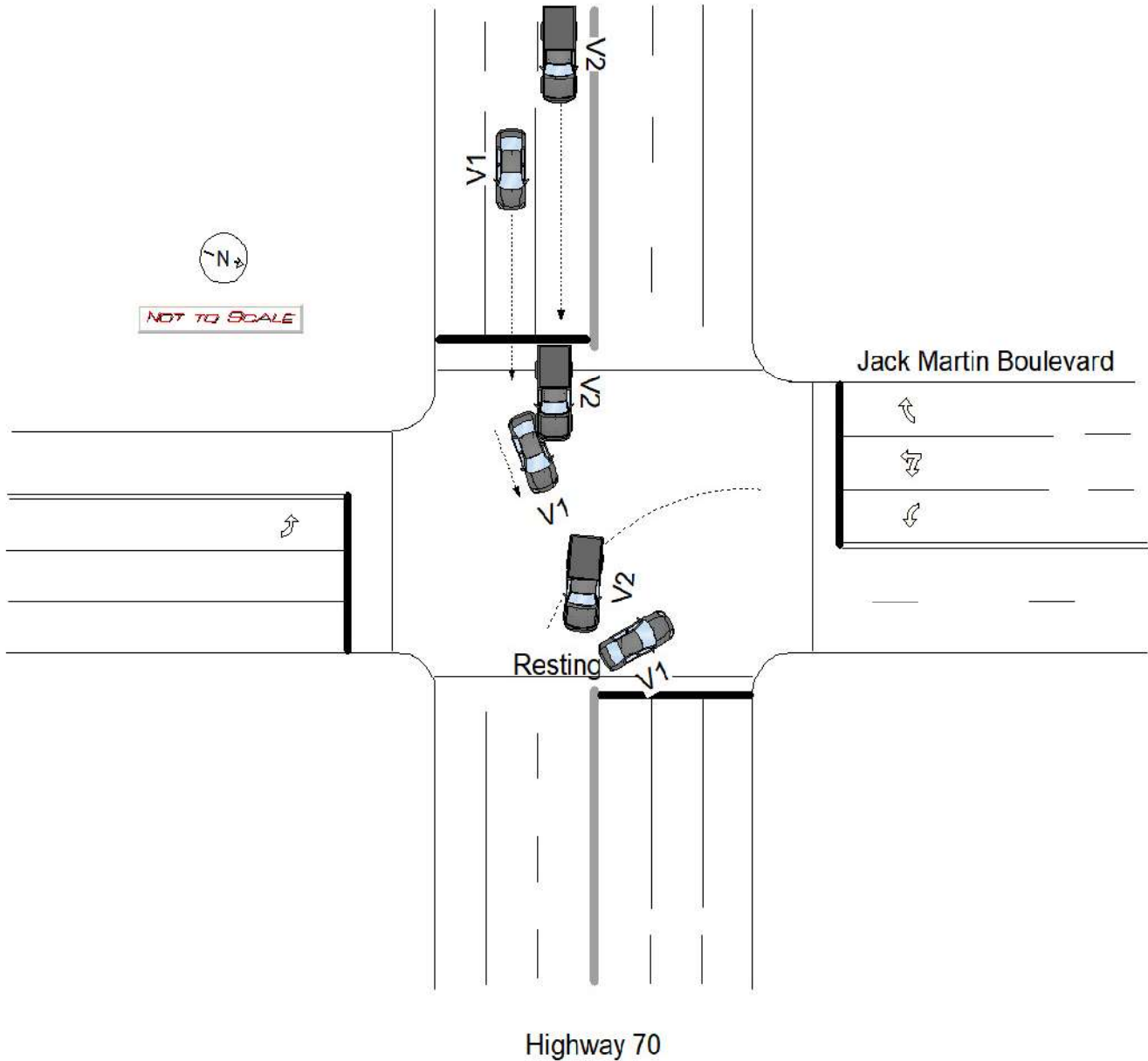
