145. Crash Description/Narrative

Vehicle one was traveling west on Rosewood Ave., approximately 150 feet west of Myrtle Ave. Vehicle one struck a utility wire that was crossing Rosewood Ave. The wire came down.

The utility wire was attached to pole # JC2335BK. It appeared to feed phone and cable service to 953, 955, 956 Rosewood Ave.

Dispatch was advised and I requested the utility companies to respond to repair the service.

The insurance information for vehicle one is: Hope Insurance Services LLC, 215 W Union Ave., PO Box 431, Bound Brook NJ 08805, 732-377-9645. Policy #01697204-0, Company # 11410.

Vehicle one was not damaged. The operator of vehicle one stated he was not injured.

The operator of vehicle one stated he was traveling west on Rosewood Ave. when he heard the wire impact his vehicle. He stated he stopped to inspect his vehicle and he observed the damaged wire.

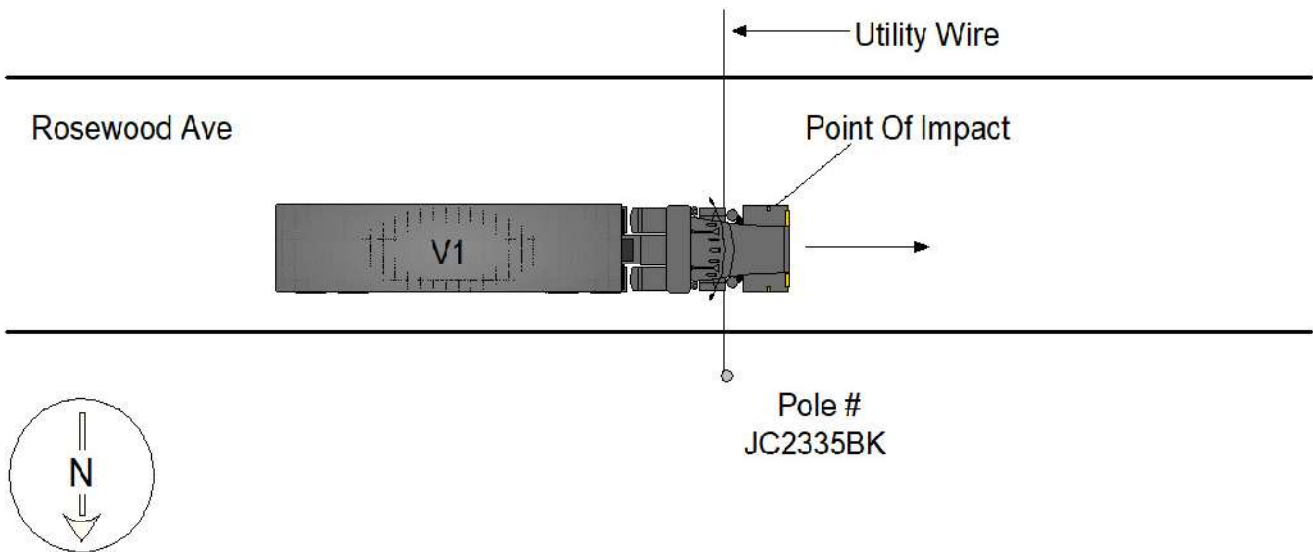
