145. Crash Description/Narrative

A motor vehicle crash occurred on Olden Street approximately 300 feet north of the intersection to Route 70. The crash occurred in front of the entrance/exit to the Home Depot (1722 Route 88).

Driver of Vehicle #1 advised she was stopped at the stop sign of the Home Depot exit waiting to turn left onto Olden Street. Driver #1 advised the vehicle in the right lane allowed her to turn left. Driver #1 advised she did not observe Vehicle #2 traveling north in the left lane and a collision occurred.

There was moderate damage to the driver side front and rear door of Vehicle #1.

Driver of Vehicle #2 advised he was traveling north on Olden Street in the left lane. Driver #2 advised he observed Vehicle #1 enter his lane of travel, attempted to brake but could not stop in time and a collision occurred.

Vehicle #2 was a Township of Brick Division of Inspection vehicle number DI-9.

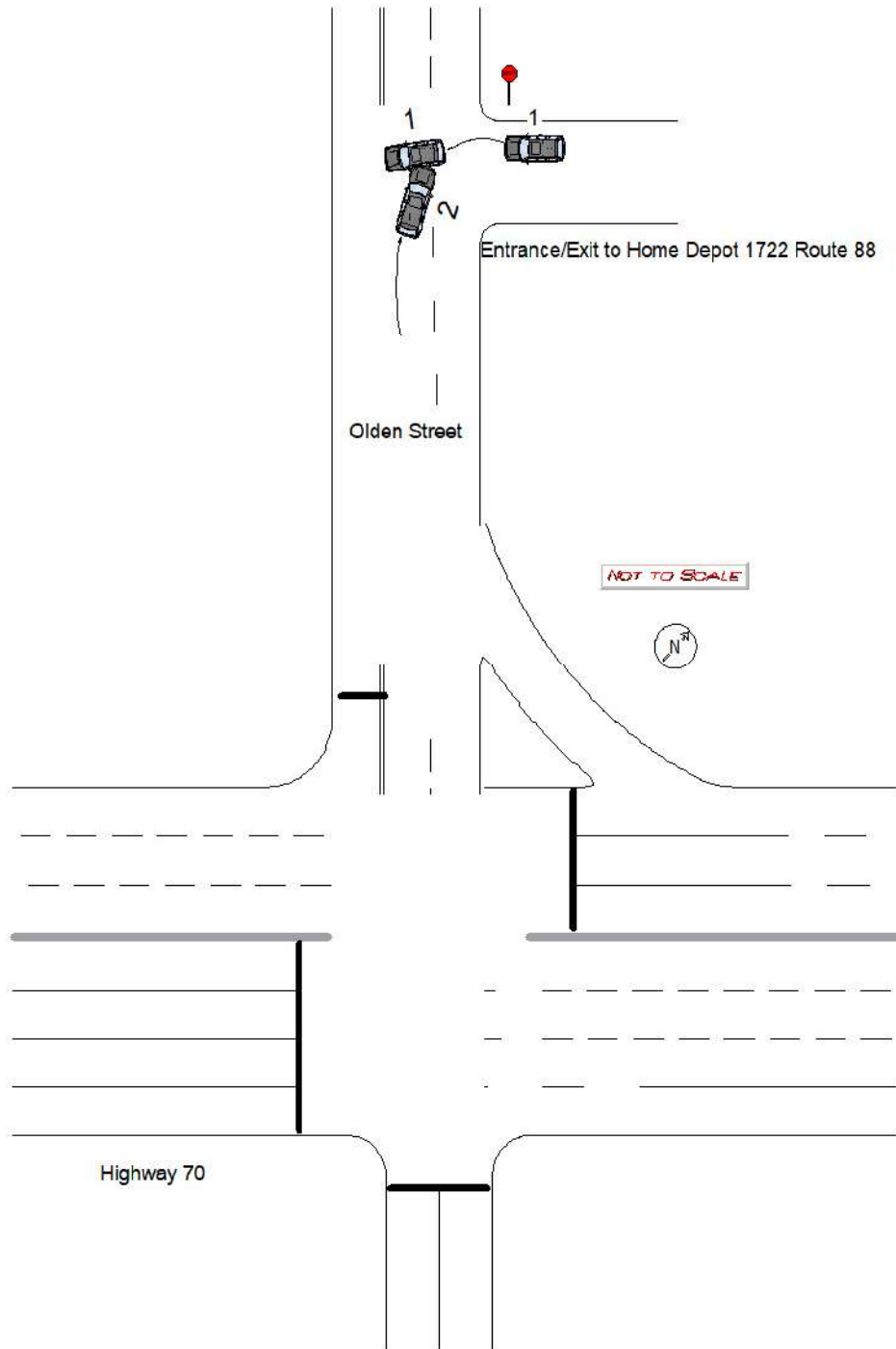
