145. Crash Description/Narrative

Vehicle #1 was traveling westbound on Route 88. Vehicle #2 was exiting the parking lot of 1608 Route 88, attempting to go eastbound on Route 88.

Driver #1 stated she made a left turn from Fort Street onto Route 88 and began traveling westbound when Vehicle #2 pulled out of the parking lot and struck the passenger side of her car, which caused her vehicle to spin 180 degrees and come to a rest facing eastbound on the shoulder of Route 88. Driver #1 was evaluated by EMS and transported to Ocean Medical Center, due to an elevated heart rate.

Driver #2 stated she was waiting to pull out onto Route 88 eastbound when she looked to her left and didn't see anyone coming. She looked to the right and then proceeded to pull onto Route 88 when Vehicle #1 ran into her. Upon further speaking with her, she stated Vehicle #1 must have pulled onto Route 88 after she already looked to her left and was now looking to her right.

Vehicle #2 was a rental car from Enterprise and Driver #2 stated she is utilizing her personal insurance instead of the insurance offered by Enterprise at the time of rental.

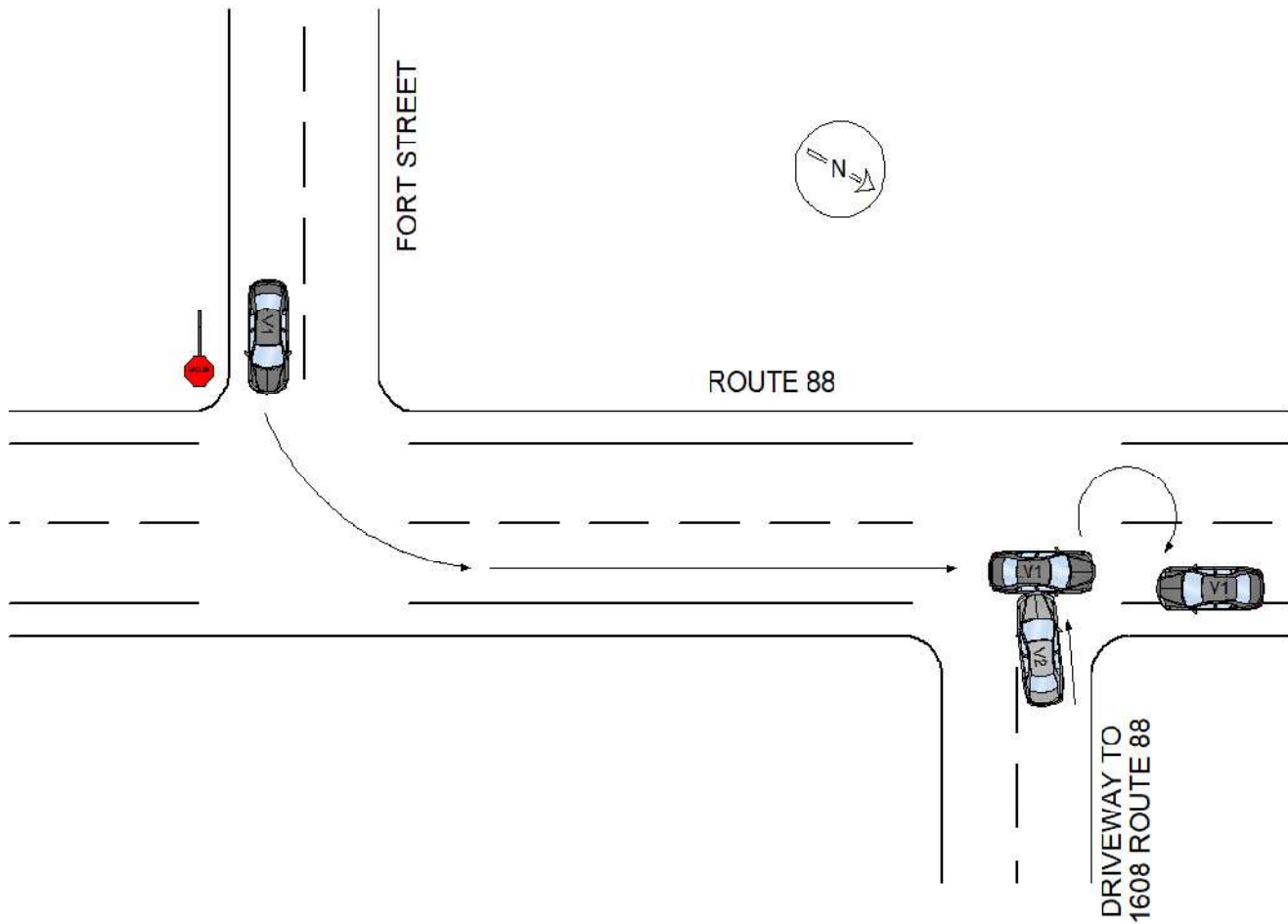
