145. Crash Description/Narrative

The driver of vehicle #2 stated he was traveling north on Rt. 88 west, approaching the entrance to Hackensack Meridian Health Ocean Medical Center, when vehicle #1 attempted to make an illegal left turn directly in front of him. He stated vehicle #1 turned left from the exit of the hospital in an attempt to travel south on Rt. 88. He further advised that vehicle #1 turned directly in front of him causing him to strike the driver side door.

The driver of vehicle #1 stated he was attempting to turn right out of the hospital and travel north on Rt. 88. He stated that he never observed vehicle #2 and pulled out directly in front of him. As a result he stated that vehicle #2 struck the driver side door of his vehicle.

The driver of vehicle #2 stated he had a dash camera inside his vehicle and could show me the crash. At this time I watched the video and observed vehicle #2 traveling north on Rt. 88 approaching the hospital entrance. I then observed vehicle #1 attempt to turn left out of the hospital and directly in front of vehicle #2. Vehicle #2 did not have any time to stop and struck the driver side door of vehicle #1. It should be noted that no left turns are allowed exiting the hospital on to Rt. 88 and is enforced with a street sign indicating so at the exit.

Moderate damage to both vehicles. The driver of vehicle #1 complained of left leg pain but refused any medical attention. The driver of vehicle #2 complained of left foot pain and was transported to the emergency room

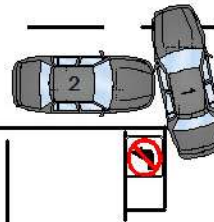

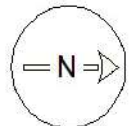
