145. Crash Description/Narrative

Driver #1 pulled out of a parking lot traveling East in the right lane on Princeton Ave approaching Post Rd.

Driver #1 attempted to cross over into the left lane directly in the path of vehicle #2 who was traveling straight ahead in the left lane.

Driver #1 stated she was lost and did not know where she was going. She stated she was in a parking lot and pulled into the right lane eastbound on Princeton Ave attempting to cross over the left lane and pull into the shopping center on the North Side of Princeton Ave. Driver #1 stated she crossed into the left lane and was struck by vehicle #2 who was traveling straight ahead.

Vehicle #2 stated she was traveling east going straight ahead in the left lane. She stated vehicle #1 crossed into her lane of travel out of nowhere and she struck her vehicle.

My investigation revealed vehicle #1 attempted to pull out of the shopping plaza and failed to observe vehicle #2 who was traveling east in the left lane. Vehicle #1's improper lane change caused the crash.

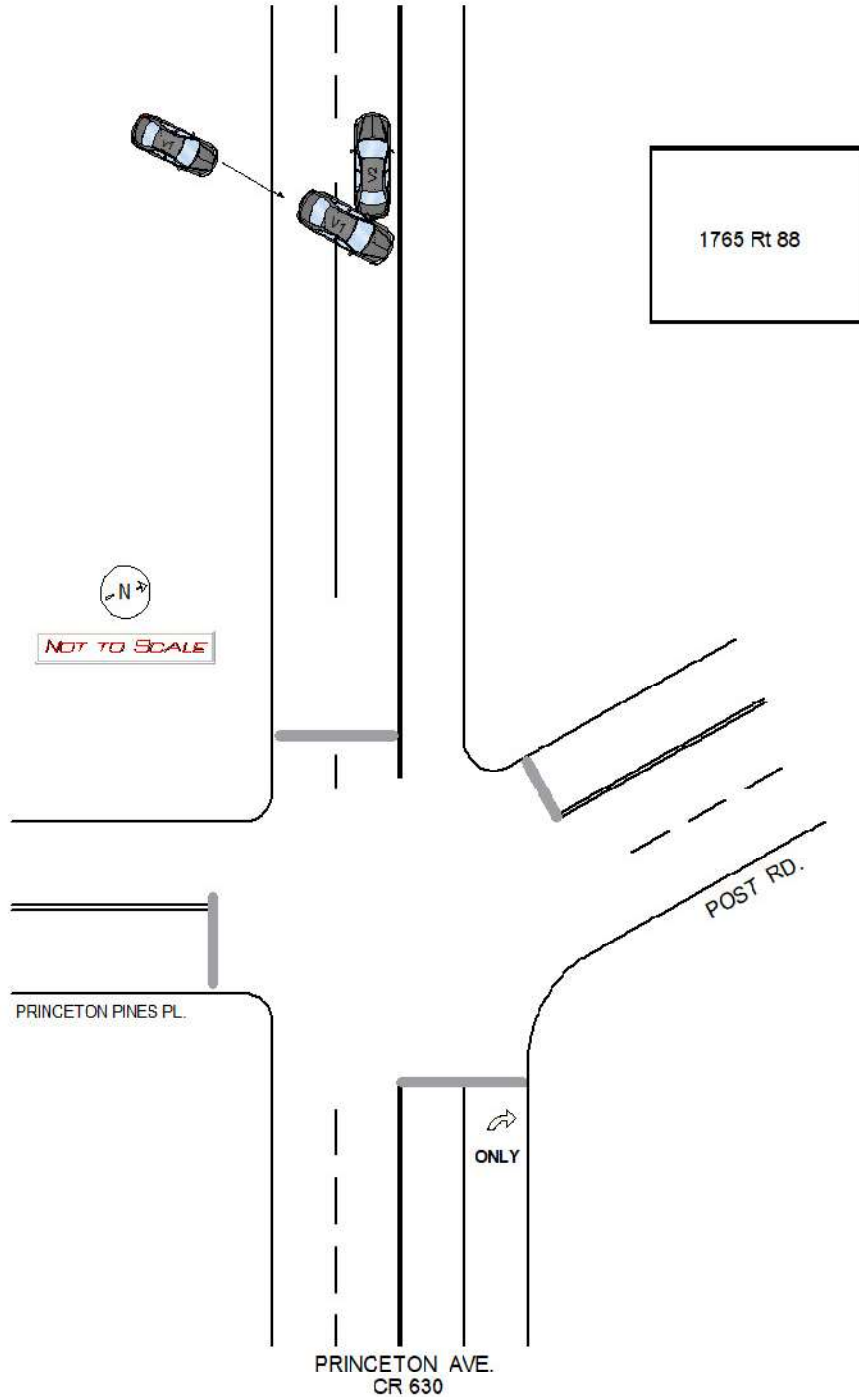
