145. Crash Description/Narrative

Vehicle 1 was stopped behind Vehicle 2, in stop and go traffic, on RT 88 West just prior to Jack Martin Blvd.

Vehicle 2 started forward with traffic but was quickly forced to a stop again. Vehicle 1 started forward with

Vehicle 2, but failed to come to a complete stop again and rolled forward into the rear of Vehicle 2.

Driver 1 and Driver 2 both stated same as above. Driver 1 admitted fault and added, when he began slowing down to

stop again with traffic, his foot inadvertently slipped off of the brake peddle, causing his vehicle to roll into

the rear of Vehicle 2.

No injuries were reported by either party and both vehicles were driven from the scene. No motor vehicle

summonses were issued.

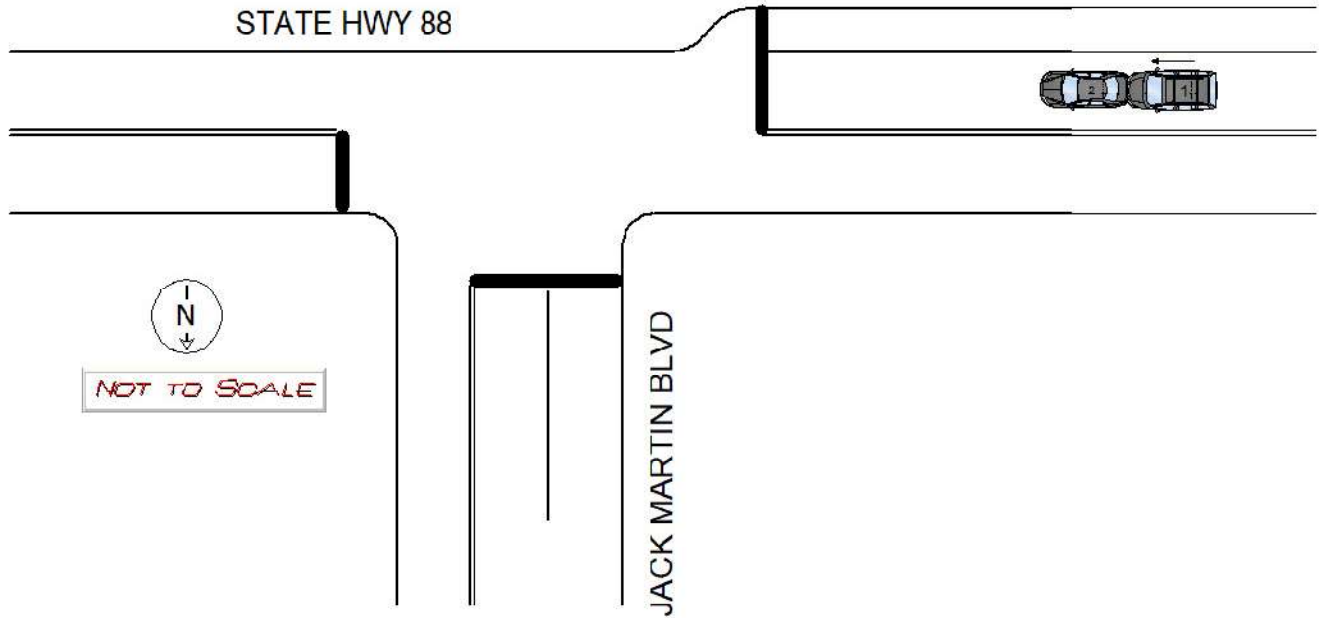
