145. Crash Description/Narrative

Crash investigation reveals a three vehicle (same direction), rear end crash. vehicles 2 and 3 were stopped in the middle lane on Route 70 W near the intersection of Route 70 W/Route 88. As both vehicles were stopped in the middle lane, the driver of vehicle 1 stated she observed vehicle 2 in front of her however, the driver of vehicle 1 stated she was unable to stop in time causing the front end of vehicle 1 to crash into vehicle 2. The driver of vehicle 1 stated she was unsure if vehicle 2 was stopped in front of her or if vehicle 2 was slowing down. The drivers of vehicles 2 and 3 stated they were stopped on Route 70 W due to an ambulance that was crossing over Route 70 with it's emergency lights and siren activated.

After the front end of vehicle 1 cashed into the rear end of vehicle 2, the force of said impact caused vehicle 2 to crash into vehicle 3. The driver of vehicle 2 complained of head pain and was treated at the scene by Brick PD EMS Unit#538. No other injuries were reported. Vehicle 1 sustained extensive damage and was towed from the scene by Glen's Towing Company. Vehicle 2 sustained significant damage and was towed from the scene by D&L Towing Company. Vehicle 3 sustained moderate damage and was driven from the scene.

The driver of vehicle 1 is at fault for the crash and was issued a motor vehicle summons for 39:4-97

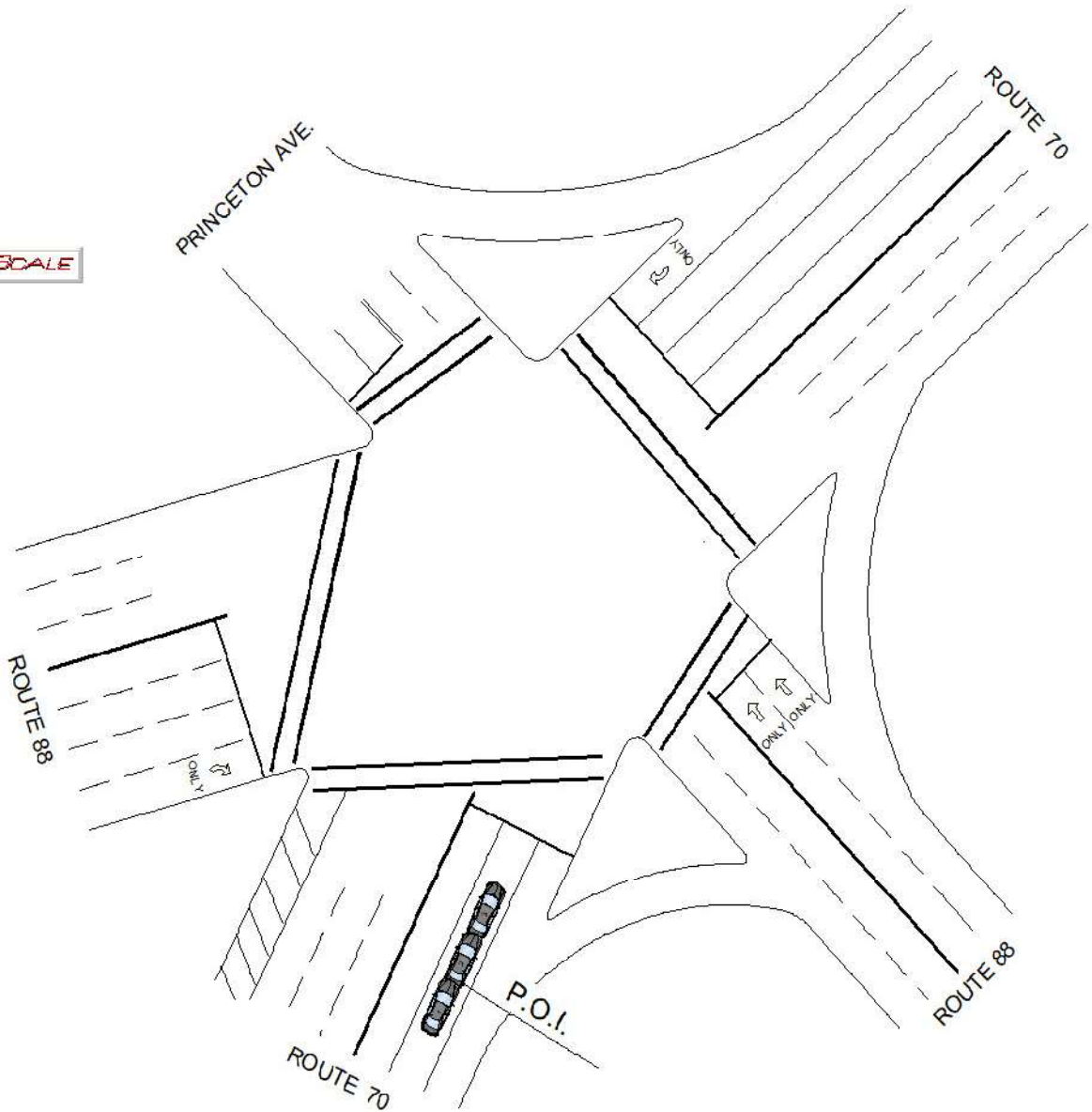
