145. Crash Description/Narrative

Vehicle 2 was traveling west on Rt. 88. Vehicle 2 slowed down and stopped on Rt. 88 to turn left into a shopping plaza. Vehicle 1 was traveling behind Vehicle 2. Vehicle 1 struck Vehicle 2. Vehicle 1 struck Vehicle 2 with the left lower front portion of Vehicle 1 causing damage to the right lower rear portion of Vehicle 2.

Driver 2 stated he was traveling west on Rt. 88. He started slowing down, stopped with his left directional signal on, attempting turning left into the shopping plaza. Driver 2 stated Vehicle 1 then struck the rear portion of his vehicle.

Driver 1 stated he was traveling west on Rt. 88. While driving he did not see Vehicle 2 stopped in the roadway attempting to make the left turn into the shopping plaza. Driver 1 stated he attempted to avoid the crash but could not. Driver 1 stated he crashed into the rear of Vehicle 2.

No injuries were reported on scene. Both Vehicle 1 and Vehicle 2 were driven from the scene.

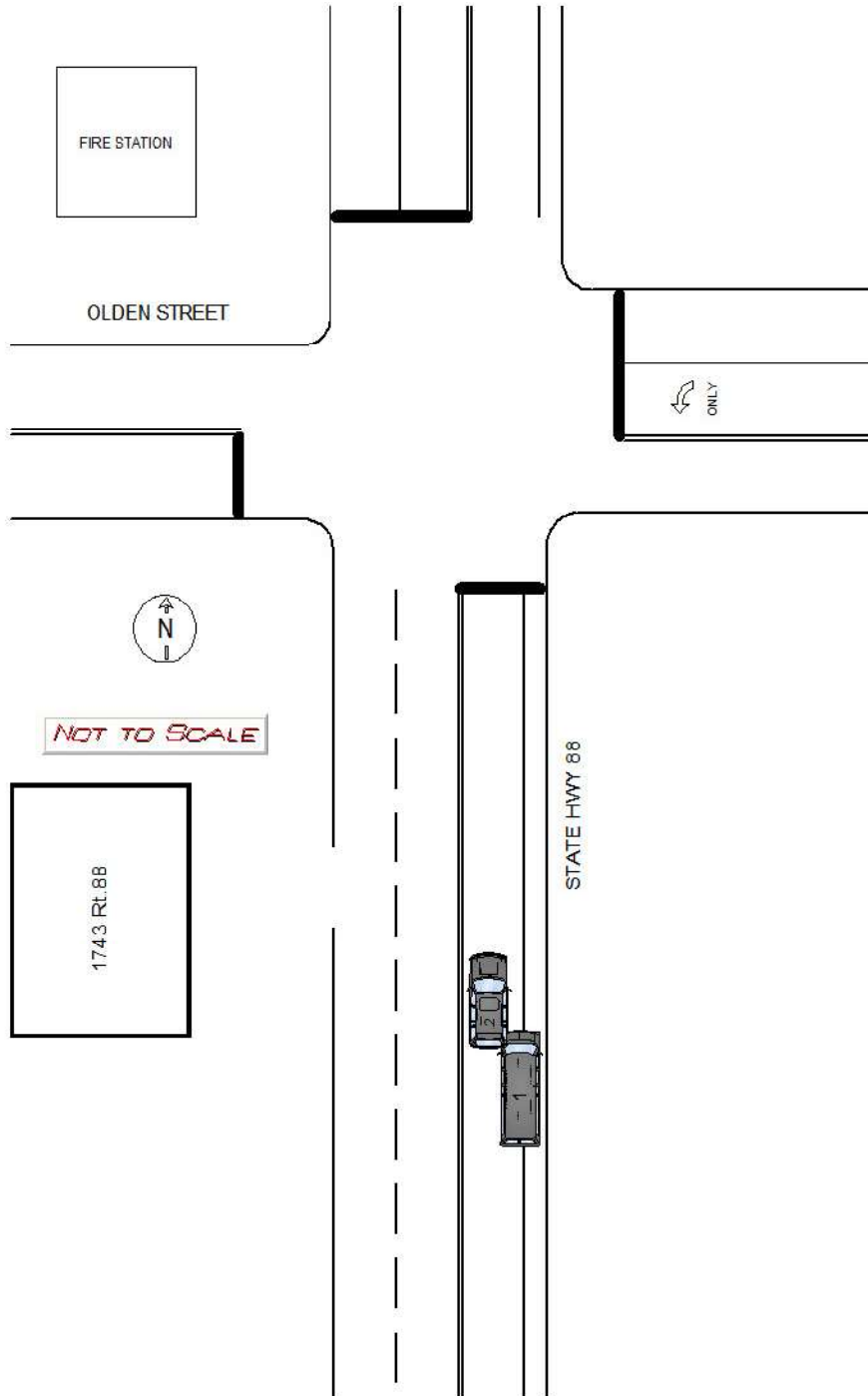
