145. Crash Description/Narrative

Both vehicles were traveling West on Olden Street. Vehicle 2 stopped at the traffic signal at the intersection of RT 88, which was red, and Vehicle 1 struck Vehicle 2 in the rear bumper with its front bumper. Both vehicles received minor damage. Driver 2 had a complaint of pain in the neck and back, but refused medical assistance. Driver 2 did not have any type of safety belt on during the motor vehicle crash.

Driver 1 advised she did not leave enough room in between traveling vehicles. Driver 2 advised her vehicle was struck when she was stopped at the traffic signal.

Based on my observations and statements made by both drivers, I find Driver 1 at fault for following too close to Vehicle 2.

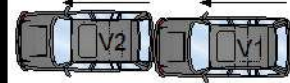
