145. Crash Description/Narrative

Vehicle 1 was directly behind vehicle 2 south on Burrsville Road at the stop sign for the intersection of Route 88. Driver 2 believed vehicle 1 was starting in traffic and began to proceed as well. Vehicle 2 stopped again at the stop sign for cross traffic on Route 88 and vehicle 1 rear ended vehicle 2.

Driver 1 stated that he was south on Burrsville Road behind vehicle 2 at the stop sign for route 88. Driver 1 stated vehicle 2 began to proceed and so did he. Driver 1 stated he did not realize vehicle 2 stopped again and he subsequently rear ended vehicle 2.

Driver 2 stated he was south on Burrsville Road, stopped at the stop sign for the intersection of Route 88 when vehicle 1 rear ended him.

Investigation revealed that the cause of the crash was due to driver 1's inattention to vehicle 2 stopping again for traffic before proceeding through the stop sign onto Route 88.

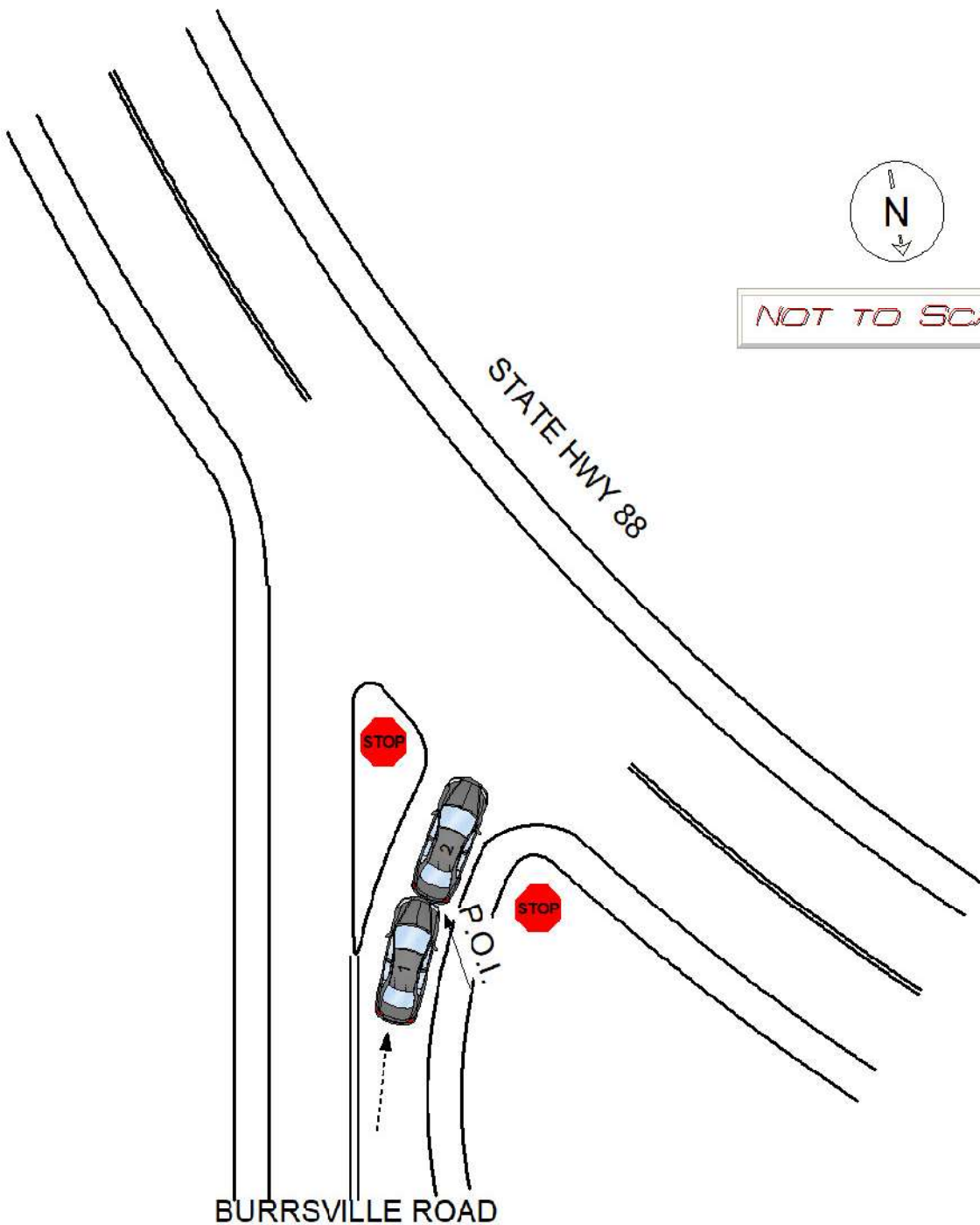
