145. Crash Description/Narrative

Vehicle 01 traveling south from the Home Depot parking lot (1722 Rt 88) and attempting to make a left turn onto Olden St. when it struck Vehicle 02 that was traveling west in the left lane on Olden St.

Driver of Vehicle 01 admitted fault stating she was leaving the Home Depot and had stopped at Olden St. waiting to make a left turn when she was waved out by a stopped vehicle in the right lane on Olden St. traveling west.

Driver of Vehicle 01 stated she then attempted to make a left turn striking Vehicle 02 traveling west in the left lane.

Driver of Vehicle 02 stated she was traveling west on Olden St. in the left lane when Vehicle 01 pulled out from the Home Depot striking her vehicle in the right front.

Both vehicles moved prior to Police arrival.

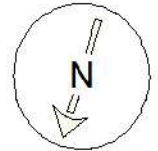

Motor Vehicle Crash Diagram

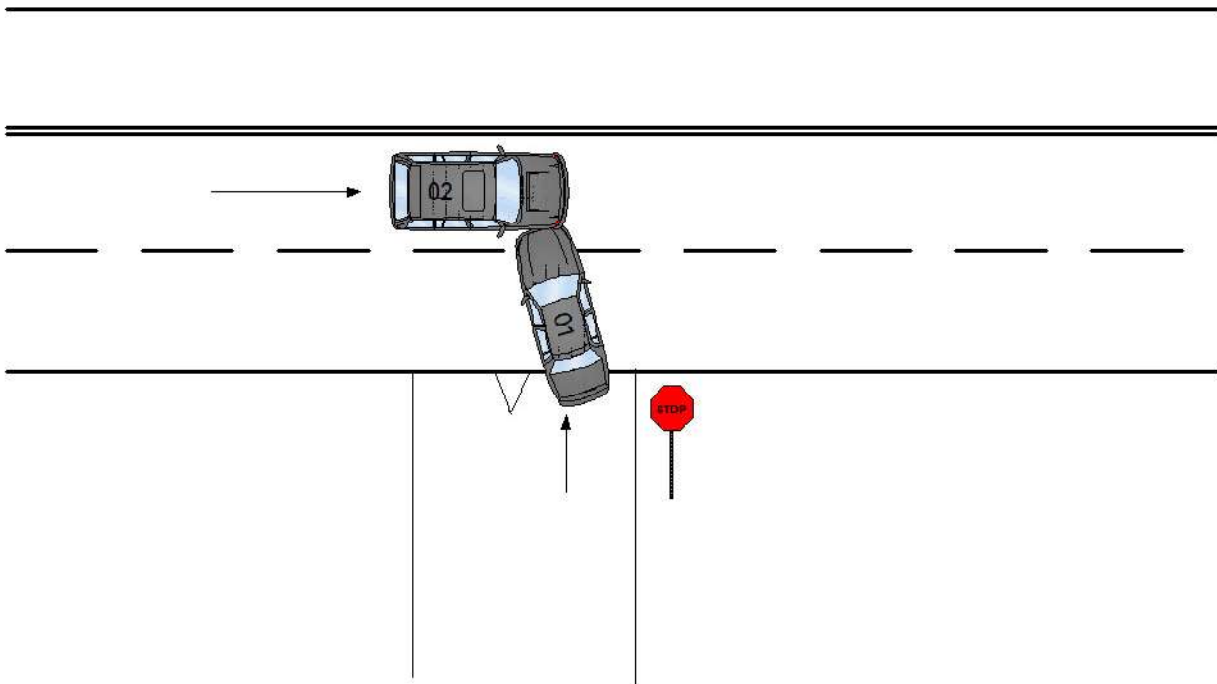
