145. Crash Description/Narrative

Vehicle # 1 heading east on Route 70 in the right lane going straight ahead. Vehicle # 2 on Olden Lane going straight ahead in the right lane through a green light. Vehicle # 1 ran the red light and went into Vehicle # 2's travel lane. At that time Vehicle # 1 impacted the left front of Vehicle # 2.

Driver of Vehicle # 2 stated he had the green light as he entered the intersection. Driver of Vehicle # 1 stated she was lost and looking the parkway and was not paying attention. A unidentified woman at the scene advised me she was directly behind Vehicle # 2 going through the green light. The unknown female left the crash scene before I was able to obtain her information.

No injuries were reported at the time of the crash. It was determined based on the evidence and the statements made on scene that the driver of Vehicle # 1 was at fault for the crash.

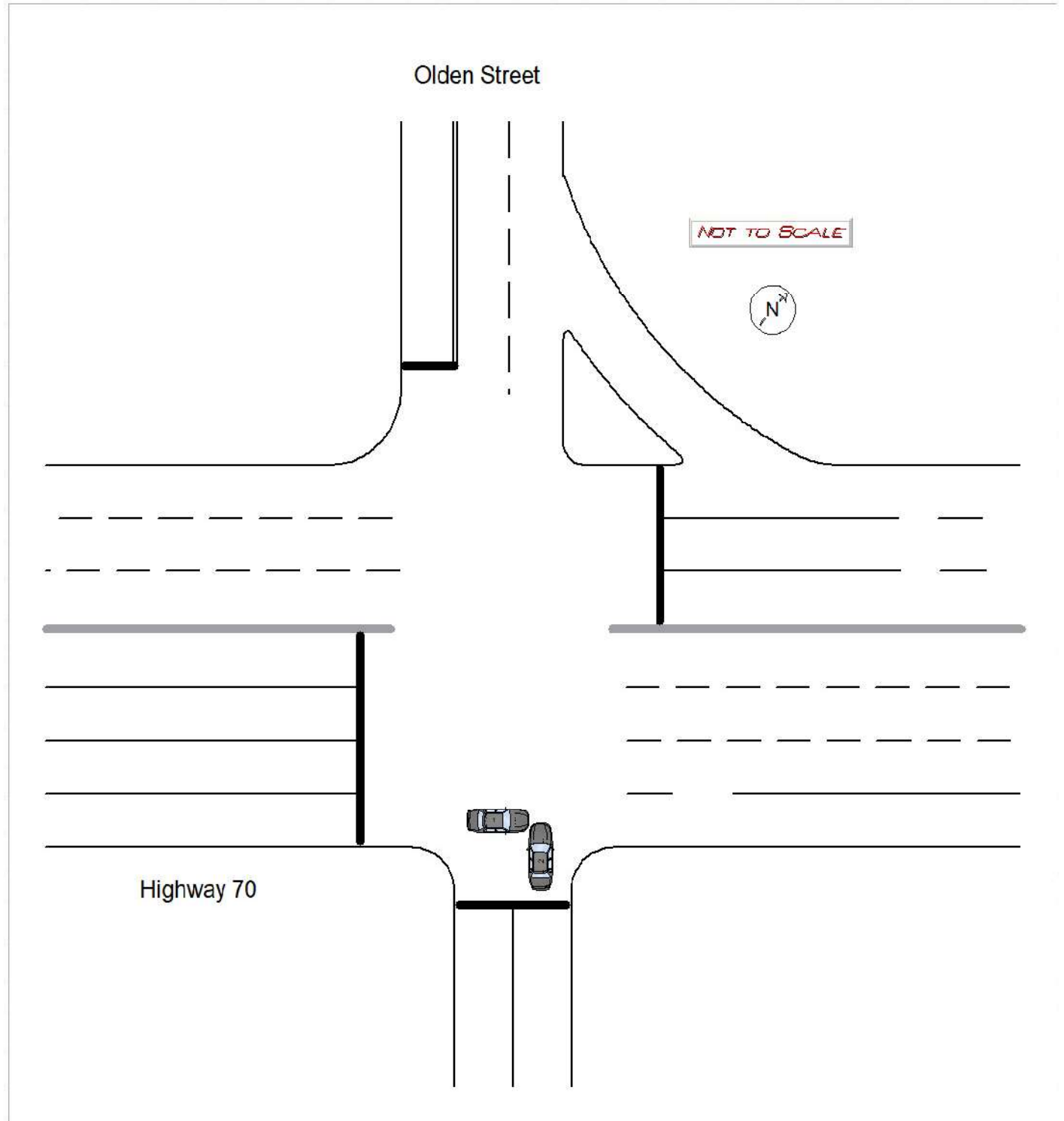
