145. Crash Description/Narrative

My investigation revealed the following:

Both vehicle 1 and vehicle 2 were traveling East on Route 70 approaching the intersection with Olden Ave. In the area of the intersection the vehicles collided. The exact location could not be pinpointed by either driver.

There was a small area of plastic transfer on the driver's side of vehicle 2. Vehicle 1 had a small amount of damage to the passenger mirror.

Driver 1 stated he was traveling East on Route 70 in the middle in the area of Olden Ave when he observed vehicle 2 drift towards his lane on his passenger side. He steered to the left to avoid the collision. As the two vehicles approached the next traffic light, driver 2 got out of her vehicle and began screaming at him. She was stating that he hit her vehicle. Driver 1 was concerned about the erratic behavior of driver 2 so he left the area to call police. Driver 1 did not believe the two vehicles made contact until he saw the small amount of damage to his passenger side mirror.

Driver 2 stated she was traveling East on Route 70 in the middle lane. She observed vehicle 1 begin to drift

left into her lane and subsequently strike the side of her vehicle. She told the driver that he hit her car and she was pulling into Walmart to check damage. Driver 1 stated he did not hit her car and left the area.

There was no physical evidence left at the scene of the crash and no witnesses to the crash. Based upon the conflicting statements given by each driver I am unable to determine who is at fault for the crash.
