145. Crash Description/Narrative

Vehicle #1 was traveling westtbound on Olden Street, from Route 70 towards Route 88.

Vehicle #2 was exiting the Home Depot Parking lot, located at 1722 Route 70.

Driver #1 stated she was traveling in the left lane towards Route 88 when Vehicle #2 pulled in front of her and struck the right front wheel of her car. Vehicle #1 suffered damage to the right front fender and tire.

Driver #2 stated he was trying to make a left turn out of the parking lot. While waiting at the stop sign, the right lane of Olden Street backed up with stopped cars and a vehicle left room so he could make his turn. While he was pulling into the left lane, he began to see Vehicle #1 traveling in the lane so he tried to stop but was already into her lane and struck Vehicle #1 with the front of his car.

Based on my observations and statements made by both drivers at the scene, I determined Vehicle #2 to be at fault for the crash.

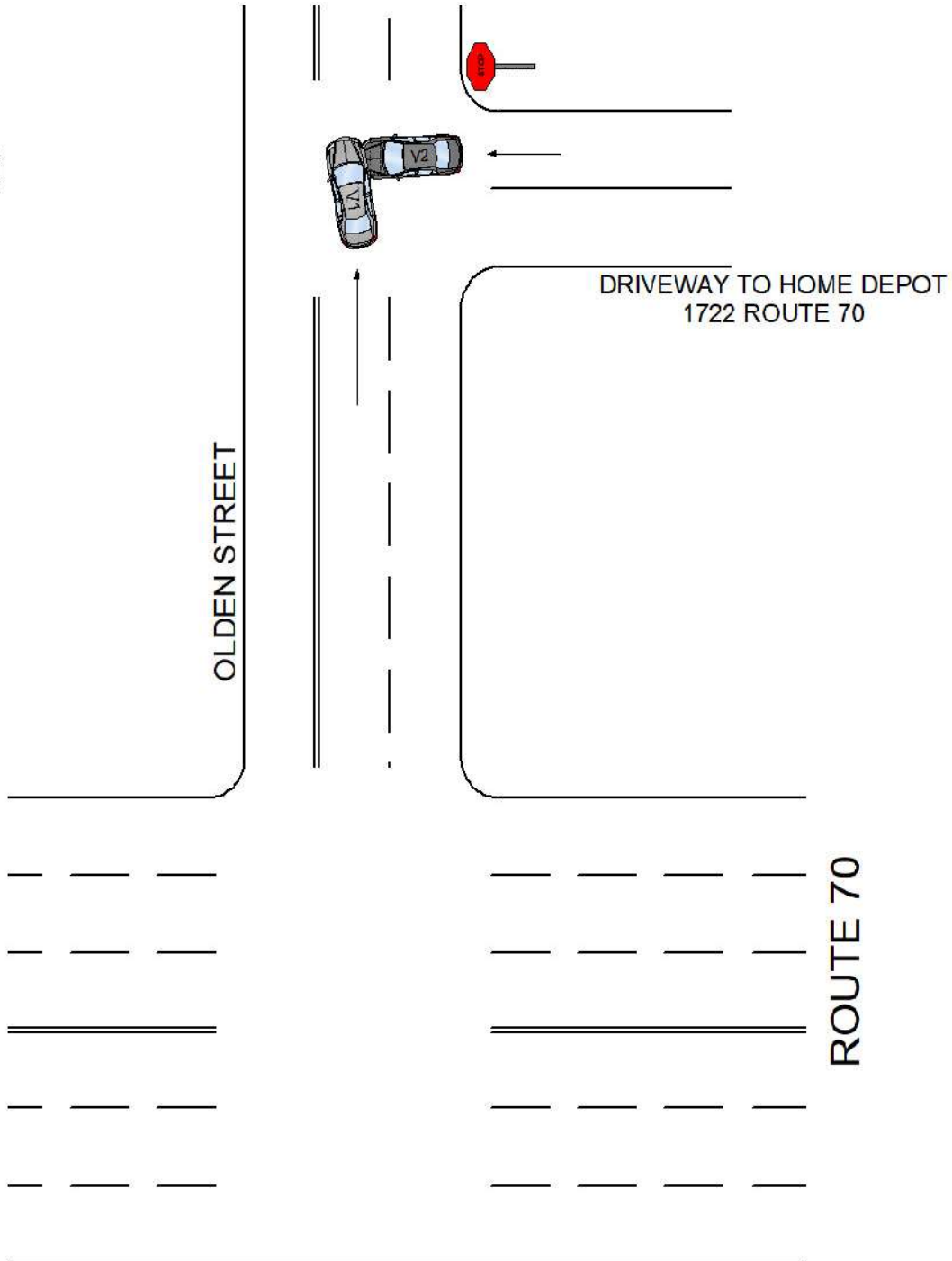
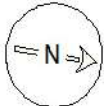
