145. Crash Description/Narrative

Vehicle #1 collided with Vehicle #2 in a rear end crash on RT 88 Westbound in the center lane.

Driver of Vehicle #1 stated he was at a complete stop behind Vehicle #2 on RT 88 westbound in the center lane.

Driver #1 stated while stopped there was a sun glare obstructing his view in front of him. Driver #1 stated the vehicle in the next lane traveled forward through the traffic light and he then removed his foot from the brake and accelerated forward assuming Vehicle #2 traveled forward. As a result he collided with Vehicle #2 in a rear end crash. Vehicle #1 sustained front end damage. It should be noted there was a significant sun glare in the area where the crash occurred.

Driver of Vehicle #2 stated she was stopped in traffic on RT 88 westbound in the center lane. Driver #2 stated as soon as the traffic light turned green Vehicle #1 struck her vehicle from behind. Vehicle #2 sustained heavy rear end damage as well as broken glass on the rear window. Both the driver and passenger had a complaint of neck pain and were evaluated by EMS but denied further medical treatment.

Based on my observations and statements made by both parties I found the driver of Vehicle #1 at fault for the

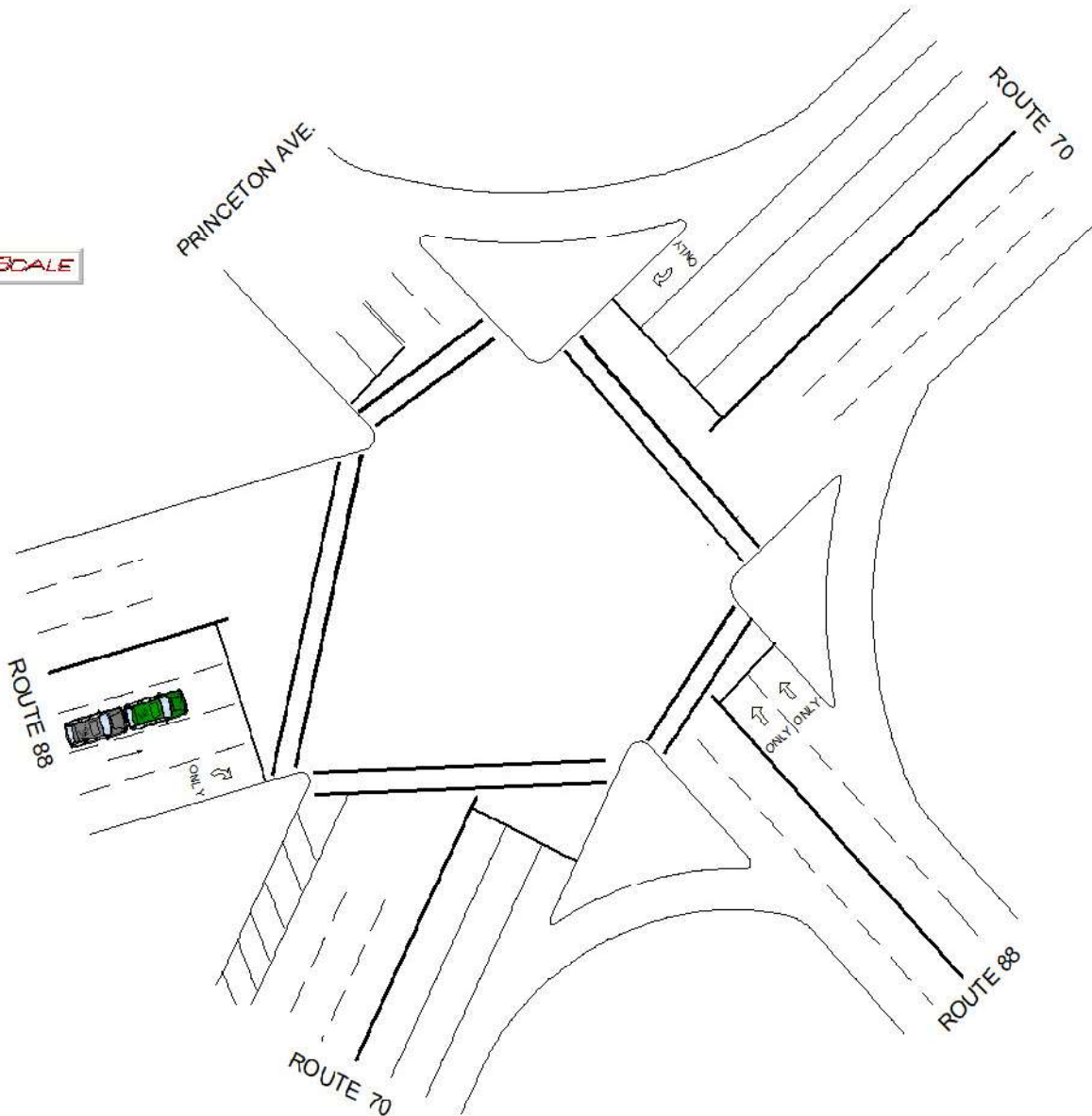
