145. Crash Description/Narrative

Crash investigation revealed that vehicle 1 was stop in traffic, waiting at the red traffic signal in the left turn lane behind vehicle 2 on Jack Martin Blvd. When the traffic light turned green, vehicle 2 idled backwards into vehicle 1.

Driver of vehicle 1 stated that she was stopped at the red traffic signal in the left turn lane, behind vehicle 2 on Jack Martin Blvd. She further stated that when the traffic light turned green, vehicle 2 reversed backwards and the rear of vehicle 2 hit the front end of vehicle 1. She also stated that after vehicle 2 hit her vehicle, it appeared that the driver of vehicle 2 was going to continue to travel without stopping. At this time she began to hit her car horn in attempt to get the attention of the driver of vehicle 2. Vehicle 2 came to a stop on the shoulder of Route 70 westbound and the driver of vehicle 1 positioned her vehicle behind his.

Driver of vehicle 2 stated that he was stopped at the red traffic signal in the left turn lane, in front of vehicle 1 on Jack Martin Blvd. Driver of vehicle 2 initially stated when the traffic signal turned green he began to accelerate forward. At this time he heard the horn of vehicle 1 only once and then felt the impact of vehicle 1 hitting the rear of his vehicle. After being hit by vehicle 1, the driver of vehicle 2 stated that he continued

through the intersection and stopped his vehicle on the shoulder of Route 70 westbound. After asking the driver of vehicle 2 again what had happened while stopped at the red traffic signal, the he stated that he was actually still stopped when he felt the impact of vehicle 1 to the rear of his vehicle.

On scene, I observed no damage to vehicle 1 and no damage to vehicle 2. Driver of vehicle 1 stated that she had no injuries. The driver of vehicle 2 and the passenger of vehicle 2 both stated that neither of them sustained injuries. Driver of vehicle 2 requested that the accident be documented only because his employer, the Arc of Ocean County, requires all accidents involving Arc vehicles be documented.

Due to the circumstances of the crash and the statements given by both the driver of vehicle 1 and the driver of vehicle 2, I was unable to determine the driver at fault in this crash.

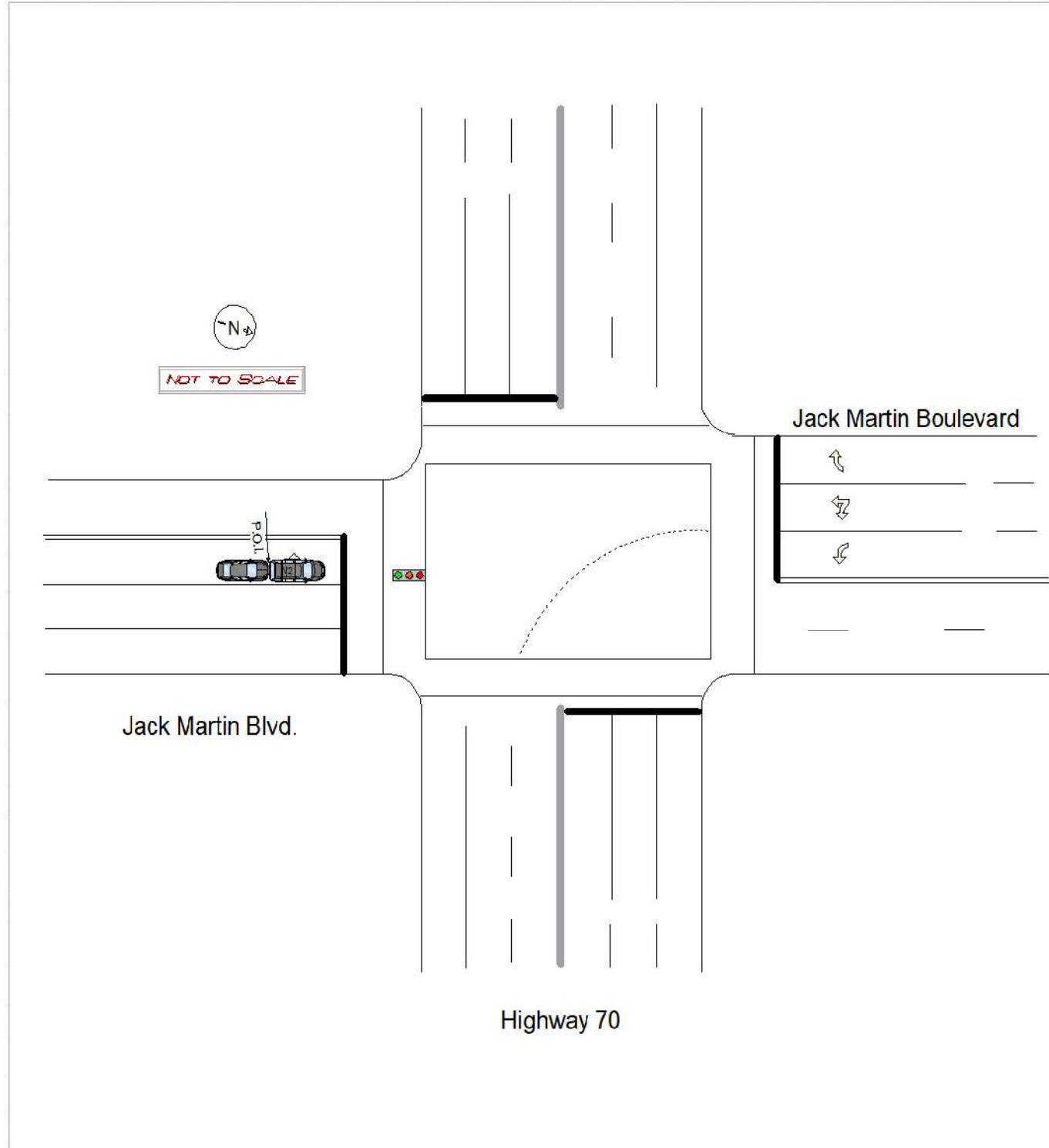
