145. Crash Description/Narrative

Vehicle 2 was parked head first into a parking space, in between the designated parking space lines, at Ocean Medical Center, 425 Jack Martin Boulevard. Driver 1 was pulling into a parking space directly next to vehicle 2 on the driver's side. Driver 1 misjudged the turn and struck vehicle 2.

Driver 1 stated he was attempting park head first into a parking space directly next to vehicle 2 when he believed he ran something over in the parking lot. Driver 1 stated he pulled into the parking spot and checked the parking lot but did not observe any foreign objects. It was not until I pointed out the damage to vehicle 2 along with the damage to his bumper that he realized he struck vehicle 2.

The owner of vehicle 2 returned to her vehicle and advised that the damage to her vehicle was not there prior to parking in the parking space on today's date. I observed scratches and dents to the rear driver's side of vehicle 2 consistent with the front bumper of vehicle 1 striking it. I also observed white paint on the front bumper near the passenger side of vehicle 1 consistent with the damage and paint color on vehicle 2.

Two witnesses on scene that work for the valet service at the hospital witnessed the crash and advised me of

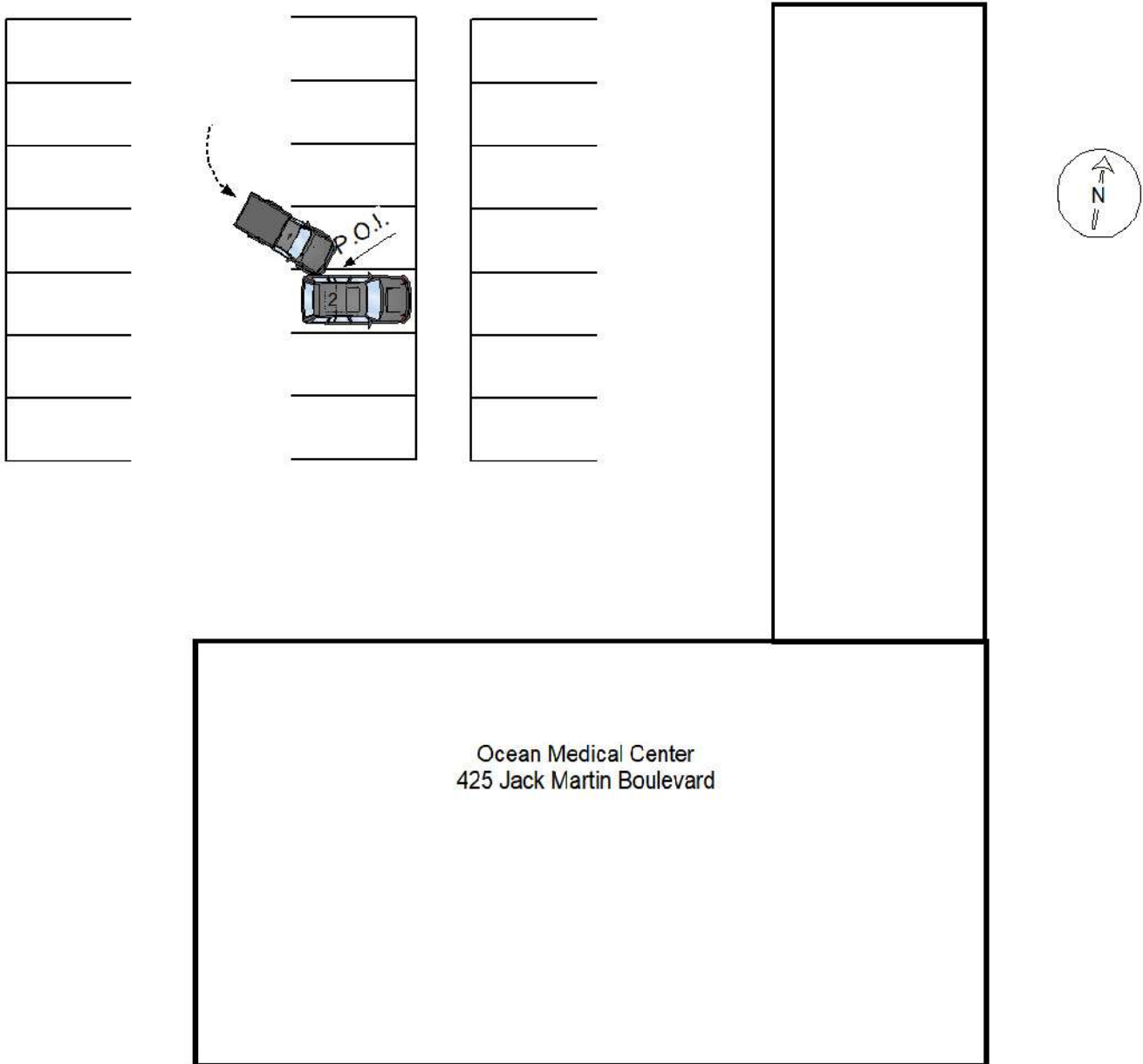
