145. Crash Description/Narrative

A motor vehicle crash occurred on Princeton Ave approximately 150 south of the intersection to Route 70.

Driver of Vehicle #1 advised he was on Princeton Ave at the traffic signal towards Route 88 west. Driver #1 advised he began moving, looked down and did not realize the Vehicle in front of him was stopped. Driver #1 advised he struck the rear of Vehicle #2.

There was minor damage to the front bumper of Vehicle #1.

Driver of Vehicle #2 advised he was stopped at the traffic signal from Princeton Ave towards Route 88 west in the left lane. Driver #2 advised the vehicle in front of him was stopped attempting to make an illegal left turn onto Route 70 west. Driver #2 advised while stopped he was struck from behind by Vehicle #1.

There was moderate damage to the rear of Vehicle #2.

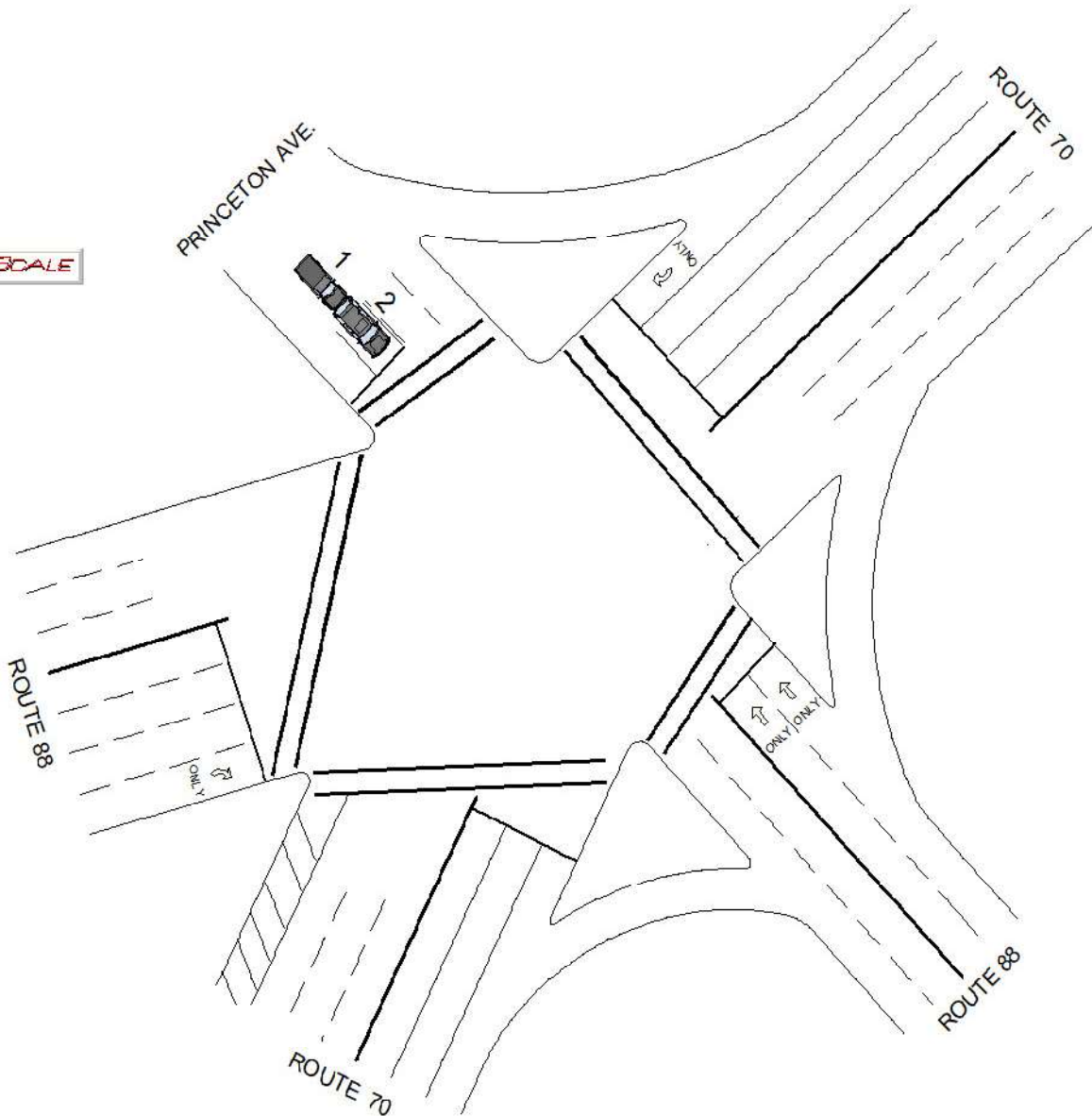
