145. Crash Description/Narrative

Vehicle #1 was parked in Ocean Medical Center, 425 Jack Martin Blvd., parking lot. Vehicle #2 was stopped in the parking lot waiting for someone to pull out of a parking stall. While vehicle #2 was waiting, vehicle #1 backed into vehicle #2. Driver #1 stated vehicle #2 was waiting to pull into a spot. When she attempted to back up, she misjudged the distance colliding with vehicle #2. Driver #2 stated while he was waiting for a vehicle to pull out of a spot so he could pull in, vehicle #1 collided with his rear end. Subsequently, Driver #1 was found at fault for the accident.

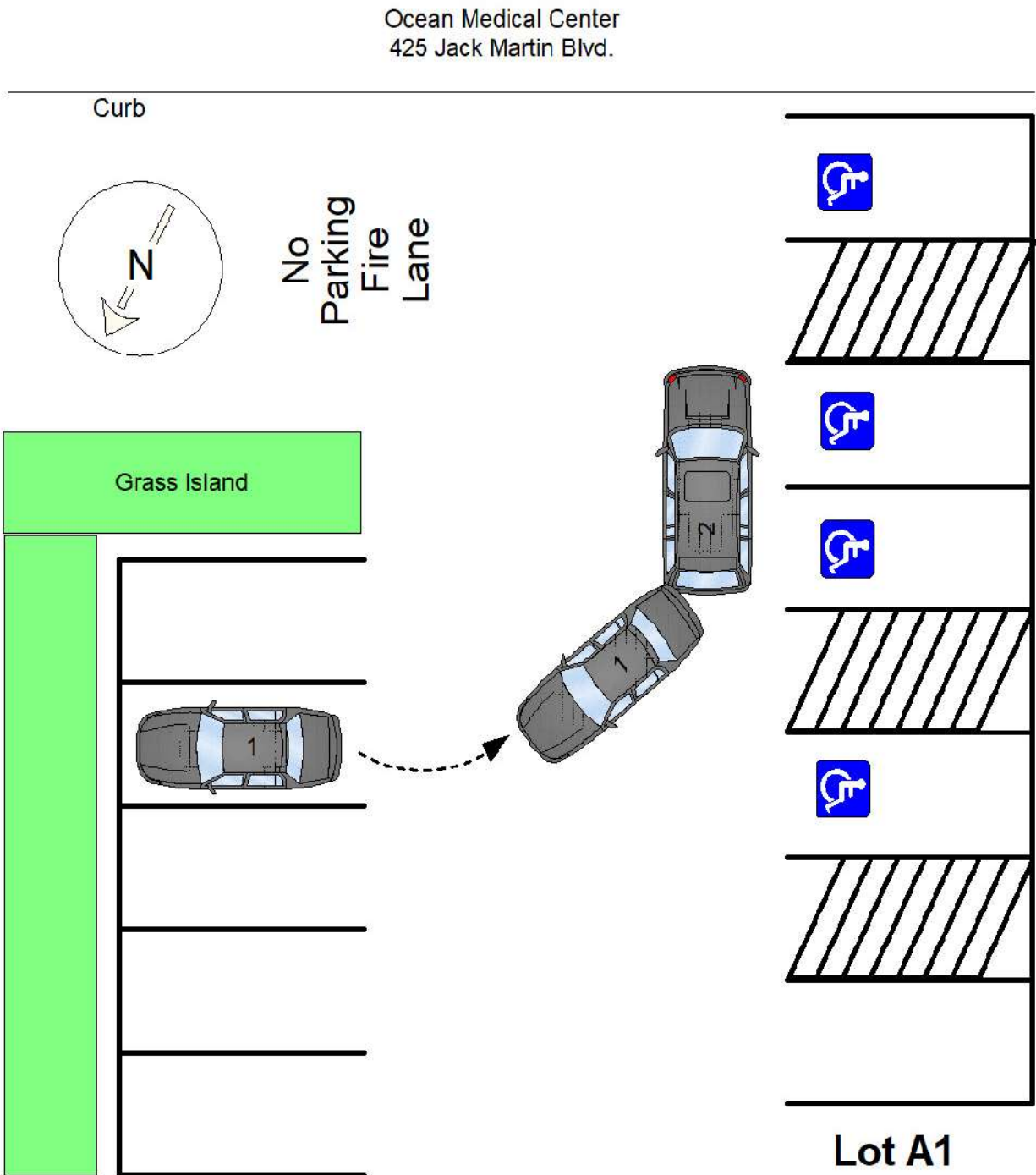
